Presentation	The retailer has a separate department in an area suitable for the relevant brand.

Collection, processing and use of your personal data

We comply with legal regulations of the EU's General Data Protection Regulation (GDPR), the German Federal Data Protection Act and the German Telemedia Act when collecting, processing and using your personal data. Your personal data will be deleted provided that this does not conflict with statutory retention requirements and if you have made a valid claim for it to be deleted.
