(57) **CLAIM**

The ornamental design for a wrench, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a front, a first end, and a first
side of an ornamental design for a wrench;

FIG. 2 is an elevational view of the first side of the wrench of
FIG. 1;

FIG. 3 is an elevational view of a second side of the wrench of
FIG. 1, wherein the second side is opposite the first side;

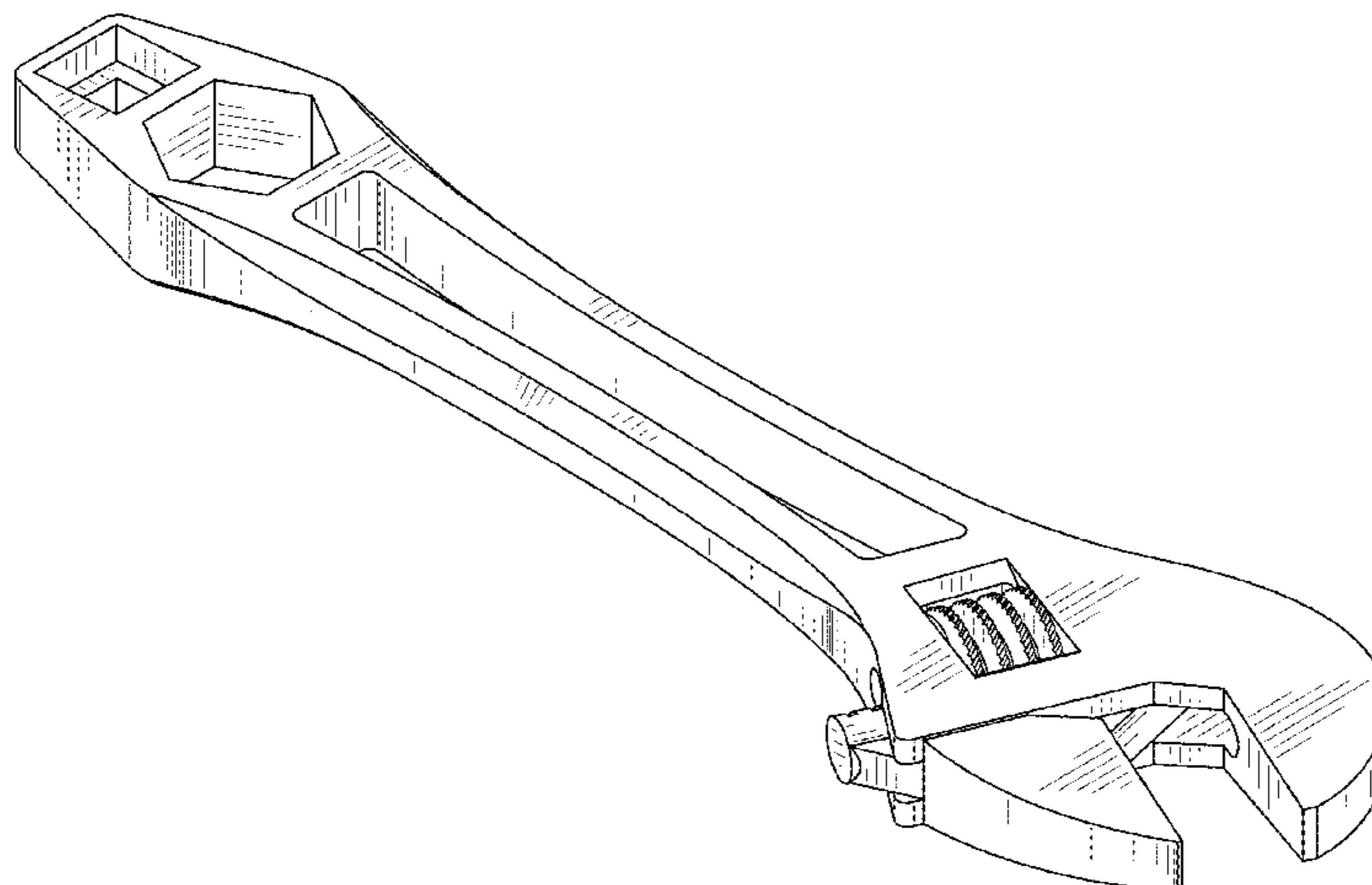
FIG. 4 is an elevational view of the first end of the wrench of
FIG. 1;

FIG. 5 is an elevational view of a second end of the wrench of
FIG. 1, wherein the second end is opposite the first end;

FIG. 6 is an elevational view of the front of the wrench of FIG.

FIG. 7 is an elevational view of a rear of the wrench of FIG. 1,
wherein the rear is opposite the front of the wrench.

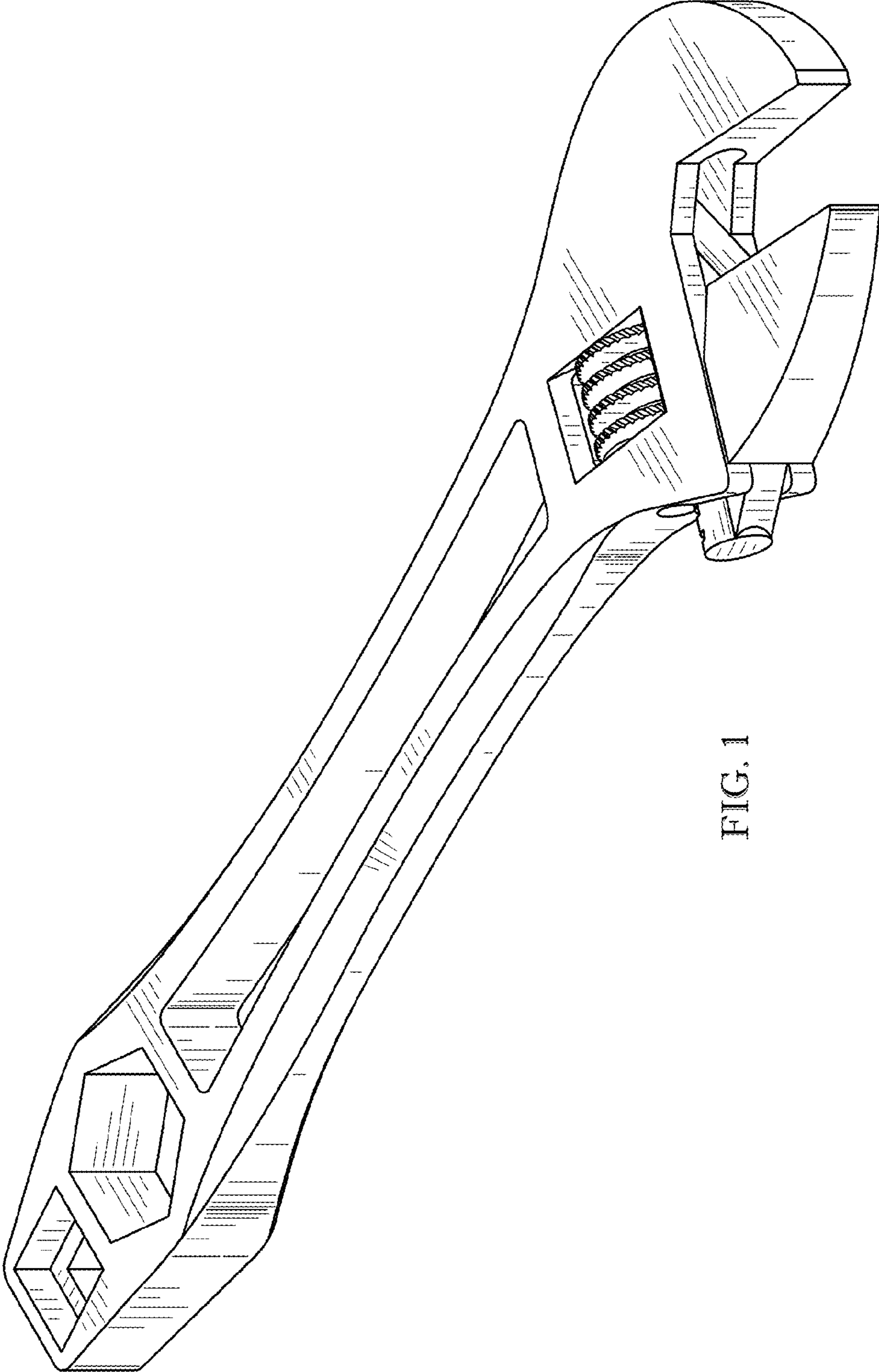

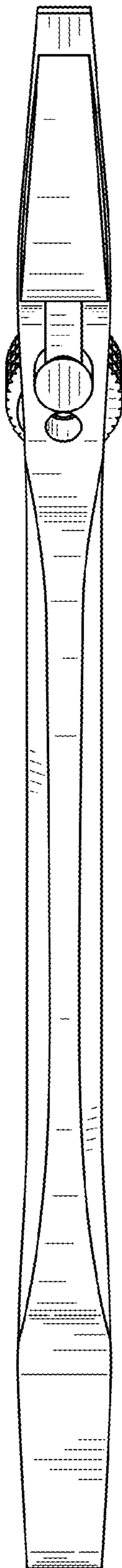

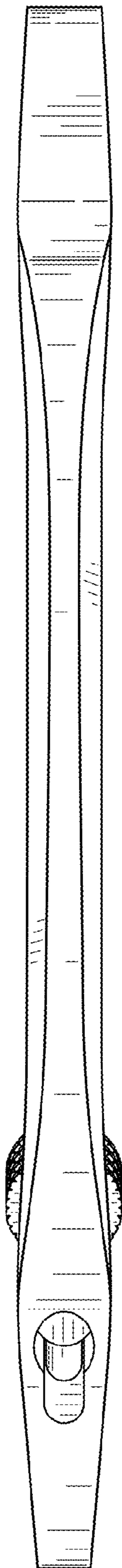

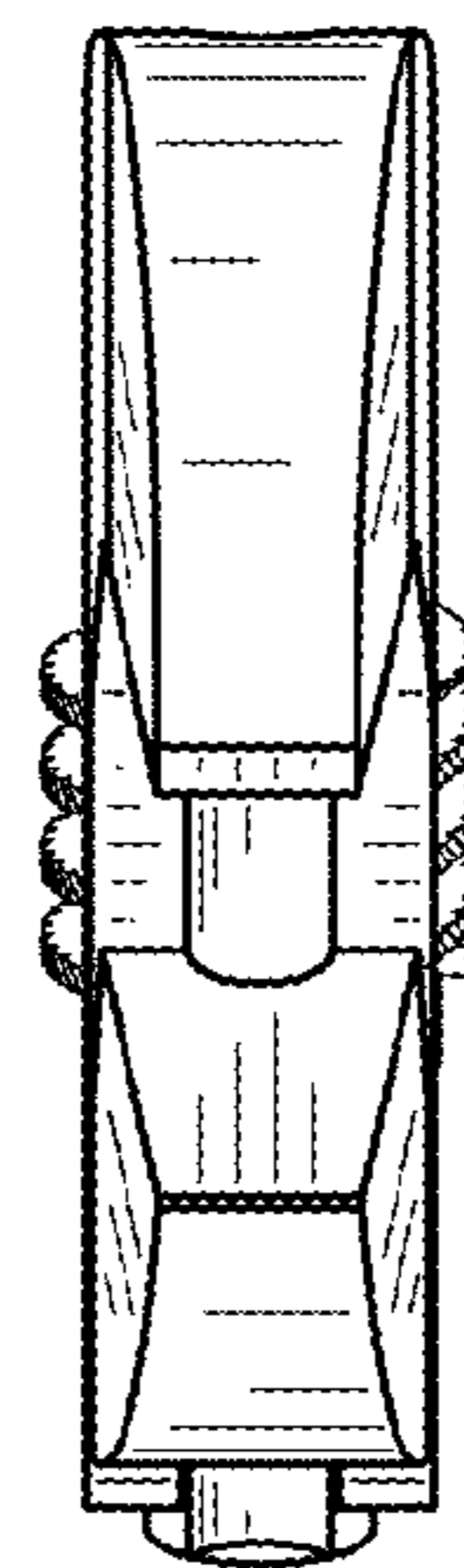

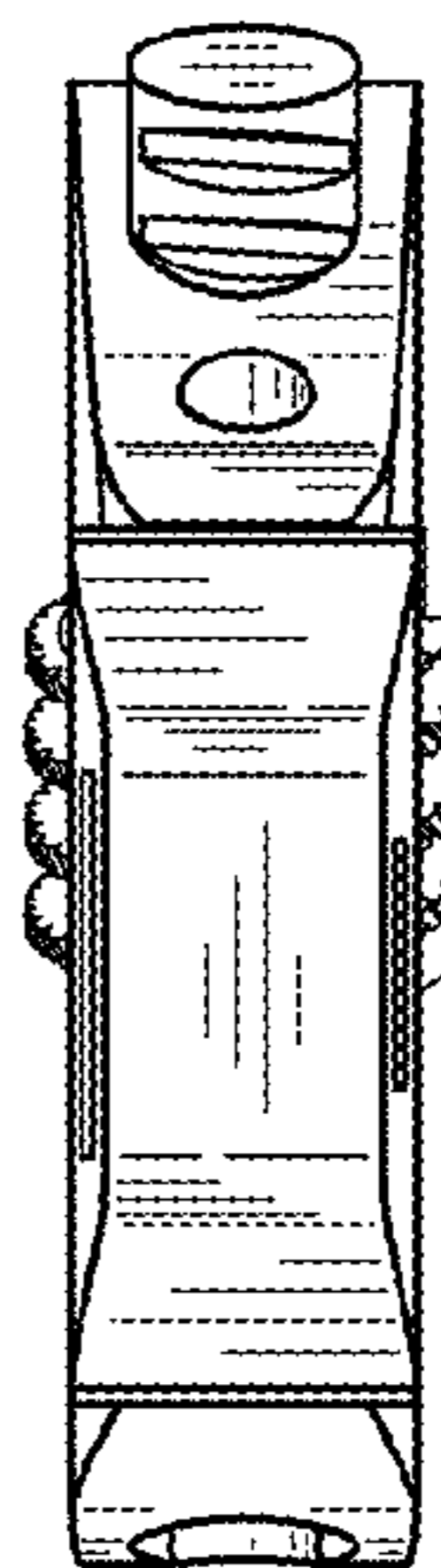

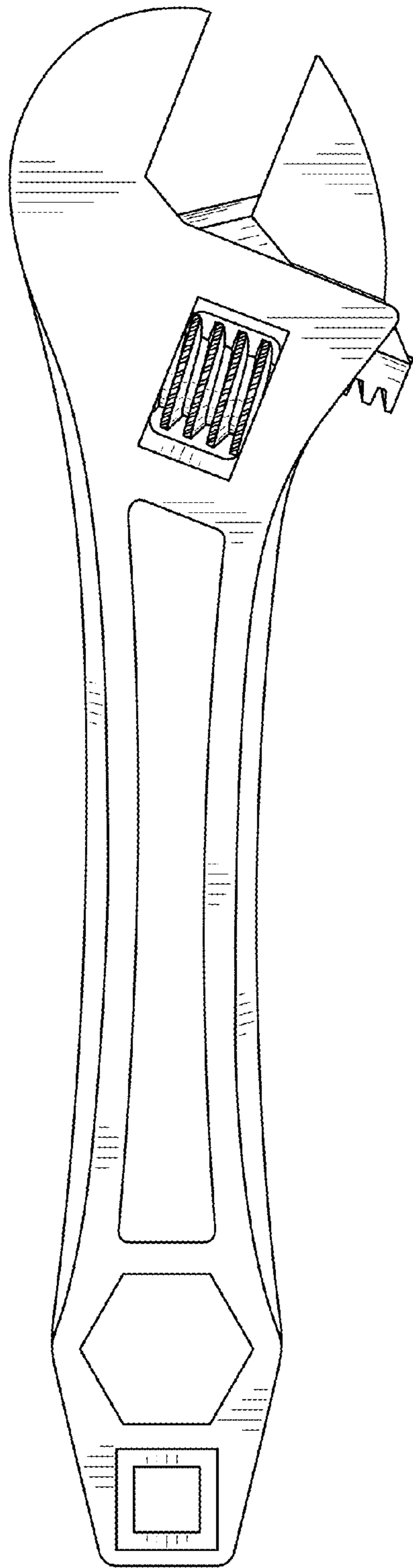

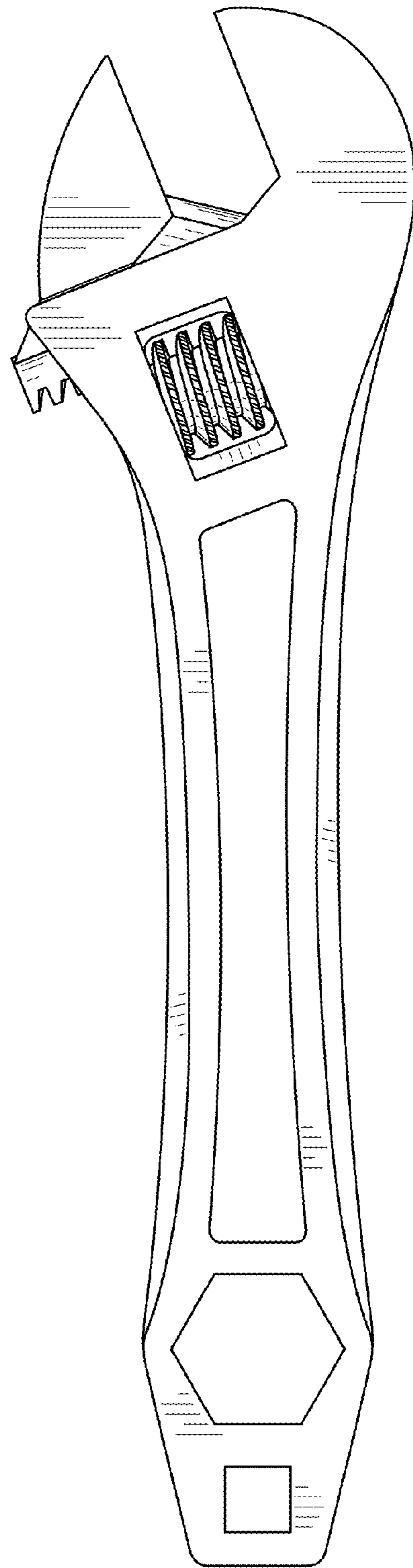
