





Hello, my name is Kaitlyn Stepp, and I am the owner of Two- Steppin' Productions LLC. Two-Steppin' Productions was born out of a tragic loss for our family. In January of this year, my husband, Andrew, and I were expecting the arrival of our fourth little cowgirl, Lainey Jayne. Little did we know that God would have a different plan for our family. Little Lainey Jayne Stepp was born with her Angel Wings on Thursday, January 09, 2025, at 11:13AM. Our sweet baby girl weighed 5 pounds, 6 ounces, was 18 inches long, and had a beautiful head of dark hair.

As you can imagine, the loss of a child is the worst nightmare for any parent. Even on our darkest day, we found comfort from the love and care we received from our hospital staff. The wonderful labor and delivery nurse handed us a box filled with many treasures from a foundation called, Born With Angel Wings. Inside the box we found a beautiful burial gown and cap sewn from donated wedding dresses, grief and burial assistance information, lovely poems, a tiny baby blanket, and so many more items that we now cherish. I was so amazed at how thoughtful the items were, and the time so many people put in to create them.

In my grief, I could feel our God's hands steadying me and telling me to just be still. In those moments of stillness, I realized he was calling me to something much greater. To heal from my heartbreak, I needed to get involved some way. I quickly reached out to the founder, Anne McCoy Ancelet. We chatted through a few emails, and she suggested that I start by making the no sew baby caps since I am sewing machine challenged! I loved working on the caps, but I still felt I was called to do more. In the days after we lost Lainey, our family, church, community, and rodeo family poured their love and support into us. Many women reached out to me with their stories of loss and listened to me when I needed to talk. "How could I repay their kindness?", I would say to myself and honor the memory of Lainey Jayne. Then it hit me like a brick wall!! I should hold an annual memorial barrel race in her name with the proceeds going to help foundations like Born With Angel Wings.

It is our goal at Two-Steppin' Productions, with your help, to host our very First Annual Lainey Jayne Memorial Barrel Race March 20-22, 2026, with a slammed full, action-packed weekend of rodeo. Our events will include: mutton bustin' for all our fearless 6 & under kiddos, goat tying & untying, breakaway, pole bending, a two-day average barrel race, and a high stakes money barrel race. We are happy to announce we will also be holding the first in our neck of the woods Buddy Barrel Pickup Race for the bravest of our contestants! What is buddy barrel pickup? The rider will race down to the barrel, where his or her teammate is standing on. As the horse circles the barrel, the second teammate must jump on the back of the horse. They will then race to the finish line. How is that for excitement? Do you own a horse or know someone who needs a jumper? We welcome all of our sponsors to join any of our events, and have a blast. If the thrills of competing aren't your style, join us as a spectator to cheer on our contestants, or come shop with our vendors.



Now that I have piqued your interest, let me tell you a little more about our memorial race. Since this is our first event to honor Lainey Jayne, we have selected Born With Angel Wings out of Baton Rouge, Louisiana to be our first recipient of the funds raise. My goal is to raise a minimum of \$10,000 to donate after expenses. You may be thinking, "How will she do this?". Let me tell you, by throwing the biggest memorial event Beauregard Covered Arena has ever seen with the help of our sponsors and the outstanding rodeo families. With your contribution we will be able to give out unique awards and added money to the breakaway, youth & open barrel races, and the high stakes money race. By adding money to the pot, we can draw in a larger number of contestants increasing our donation potential. We are currently working on joining incentives such as BBR, Hooey Jr. Patriot, Southern Fortunes Stallions, and a few others to also draw in more entries. We will be offering several different sponsorship levels to fit everyone's budget. You will see the level breakdowns next in our sponsorship packet along with the awards to be given. 

BORN WITH ANGEL WINGS STORY

Cliff (my husband) and I have between us 6 children, 15 grandchildren, and 13 great grandbabies, 6 of which are in Heaven. This is how Born with Angel Wings began. At the end of 2014 when we lost our first great grandbaby, I was having a hard time with grieving.

At that time Cliff and I, were traveling with his job in McAlester, OK, which has an abundance of low-income families with infant death rates being very high. During the long days while Cliff was working, I found that crocheting tiny blankets brought me some comfort. Two of my friends from high school also started making blankets and sending them to me. The little blankets started to stack up. I then started buying baby flannel to make tiny Angel Gowns as I felt as though God had put on my heart to prepare burial garments for grieving parents. Our stay in Oklahoma ended and we headed back home to Louisiana.

After getting home, I couldn't shake the feeling that this was what God wanted us to do. It soon became a passion for the both of us to provide garments to families who had lost babies too soon. One morning as I sat on the edge of the bed, I prayed a very simple prayer. I told God that this was His ministry and we needed some help if this was our calling. Within a week, God started to open doors. Ladies were calling me to volunteer their time and special talents. In 2017, Born with Angel Wings became a reality as we officially received our status as a 501c3 Non-Profit Organization.

We now have 3 groups in 3 parishes that meet for workshops to volunteer their talents. Our workshops are a time for everyone to share their passion, work together, share ideas, meet new friends, and reunite with old ones. We provide our hospitals with beautiful Angel Memory Boxes, which are given to grieving parents at no charge to anyone. This ministry is dedicated to our own angels, and those of our volunteers. We keep them in our hearts as we dedicate our time to comforting those who have shared the same losses.
