TUNING STEPS

- 1) Polaris plug the Power Vision 3 (PV3) into the diagnostic port power the unit up to the key on position, then Vehicle Tools > Read ECU.
- 2) Plug PV3 into windows based PC email <u>calibrations@warrantykillerperformance.com</u> all files on the PV3 with order number in subject line. Skip to line 6.
- 3) Can Am plug the Power Vision 3 (PV3) into the diagnostic port power the unit up to the key on position.
- 4) Plug PV3 into windows based PC email <u>calibrations@warrantykillerperformance.com</u> all files on the PV3 with order number in subject line. Skip to line 6.
- 5) Send an email to: <u>calibrations@warrantykillerperformance.com</u> with:
 - Your order number in the subject line.
 - Your PV info folder and all files on device in the body message.
- 6) Once your email is processed you will receive a response back with a custom tune file.
- 7) Save the custom tune file in your PV3.
- 8) Upload the custom tune file in your vehicle via Flash Tune > select file starting with WKP.

REMOTE TUNING

- 1) Follow steps below unless unit throws check engine light, is above 14.7 AFR, or runs rough at any point.
- 2) Start unit cold, start data log with (circle button) let unit idle up to operating temps stop data log.
- 3) Start data log rev unit slow progressive throttle in neutral all the way to red line stop data log. Should take 10 seconds from idle to red line one throttle progression.
- 4) Start data log drive unit light throttle no more than 25%, stop and progress how quick you open the throttle to %25 let unit reach top mph for 25% throttle each run all in one data log then stop data log.
- 5) Start data log repeat steps above to 50% throttle 4 times stop data log.
- 6) Start data log repeat steps above to 75% throttle 4 times stop data log.
- 7) Start data log repeat steps above to 100% throttle 4 times stop data log.
- 8) Plug PV3 into PC email files to calibrations@warrantykillerperformance.com order number in subject line.

DIAGNOSTICS

- 1) If the unit has existing check engine light plug PV3 and key on the unit Vehicle Tools > Diagnostics > Active Codes > Historic Codes > Email those to <u>calibrations@warrantykillerperformance.com</u> > Clear Codes.
- 2) Start unit, start data log (circle button) drive unit until problem exist stop data log.

3) Plug PV3 into PC email files to calibrations@warrantykillerperformance.com order number in subject line.
