ESTIMATED INSTALL TIME

1-2 Hours

STEPS

- Remove OEM rivets (P/N: 293150108) using 3/16" drill bit and electric drill.
- 2) Remove the skid plate.
- 3) Use angle grinder or metal file to grind away any remaining metal pieces after drilling out rivets.
- 4) Drill out all existing rivet holes using 3/8" drill bit.
- 5) Insert the rivet nuts into the frame and add M6 washers and M6 bolts to hold the skid plate in place.
- 6) Use blue Loctite on all bolts before tighten all bolts using 4mm allen wrench.
