#### INSTRUCTIONS FOR DIAGNOSTICS

1. Power computer on by pressing the right corner button with no markings, once.
2. When powered on, press [ENTER], select bottom left corner **WKP Customer**.
  - Password: wkp **\*Password is CASE SENSITIVE**
3. Connect computer to Wifi. The computer will have to remain connected to Wifi in order to connect to your unit.
4. Contact us either two ways to setup a walk through for diagnostics:
  1. Email [sales@warrantykillerperformance](mailto:sales@warrantykillerperformance) and include your order # in the subject line, or;
  2. Visit [www.warrantykillerperformance.com/schedule](http://www.warrantykillerperformance.com/schedule) for hassle free scheduling.
5. Connect computer to unit using the diagnostics port.
6. Key on unit.
7. Warranty Killer Performance will walk you through next steps either by phone or email.
8. Once remote diagnostics are complete, please make sure computer is charged and powered down for return shipping.

#### INSTRUCTIONS FOR RETURNING COMPUTER

1. Package up the computer, cables and other included accessories being returned in a sufficiently sized box. Use padding or other packaging materials to help ensure no damage occurs during shipping.
2. Please write your **name**, **order #** and **phone number** inside the return box prior to taping or sealing it.
3. Seal the box with tape on all corners and open edges.
4. Purchase a return shipping label online or in-store at any major shipping carrier. Print the prepaid shipping label and place it on the return box.

**We recommend using a reputable tracking service such as UPS, USPS, FedEx or DHL Express to ship your items back to us. Ensure your package has the correct amount of insurance should your package get lost or damaged during transit.**
