- · Impact Wrench
- · Torque Wrench
- · Red Loctite

ESTIMATED INSTALL TIME

5-10 Minutes

STEPS

- 1) Remove the OEM primary bolt.
- 2) Clean crank threads with brake cleaner and make sure all residue is evaporated.
- Put some red loctite on the threads of the HD primary bolt. (Primary bolt is the longest of the two)
- 4) Install the HD primary bolt in position and torque down to 75 ft lbs. It is best to use an impact wrench and verify torque specs with torque wrench.
- 5) Remove the OEM secondary bolt.
- 6) Clean crank threads with brake cleaner and make sure all residue is evaporated.
- 7) Put some red loctite on the threads of the HD secondary bolt. (Secondary bolt is the shortest of the two)
- 8) Install the HD secondary bolt in position and torque down to 45 ft lbs. It is best to use an impact wrench and verify torque specs with torque wrench.
