STEPS

- 2) Remove passenger side panel below seat and the panel beside the seat belt buckle (center console).
- 3) Unplug the harness from the gear selector switch.
- 4) Plug the unlocker harness in the gear selector switch and back in the stock harness.
- 5) Install both passenger side panels back in position.
- 6) Install passenger side seat back in position.
