ESTIMATED INSTALL TIME

15-30 Minutes

STEPS

- 1) Disconnect OEM brake pedal spring (P/N: 705600792).
- 2) Remove OEM brake pedal bolt (P/N: 230603046) and nut (P/N: 233201436) using 15mm socket and 15mm wrench.
- 3) Remove master cylinder adjustment pin from OEM brake pedal.
- 4) Install master cylinder adjustment pin to beast brake pedal. *Make sure to properly seat master cylinder adjustment pin into master cylinder. Failure to do so will result in brakes dragging.
- 5) Reconnect the brake pedal spring. *After installation make sure UTV rolls free and brakes are not dragging from improper installation.
