STEPS

- 1) Remove belt box cover.
- 2) Spread secondary and remove CVT belt.
- Remove old transmission input shaft seal with seal puller. Please be careful to not dig into the inside diameter of the transmission case where the outside diameter of the seal mates with the transmission case to seal.
- 4) Apply brake cleaner to the input shaft and transmission case for any dust, dirt or debris.
- 5) Apply grease to the o-ring and seal lip for easy press installation. Doing so will help keep the o-ring and seal lips from rolling during the installation process.
- 6) Slide the aluminum input shaft cover over the input shaft once at the transmission case and make sure to press or tap the cover square as the interference fit for the o-ring to seal the outside diameter is very precise.
