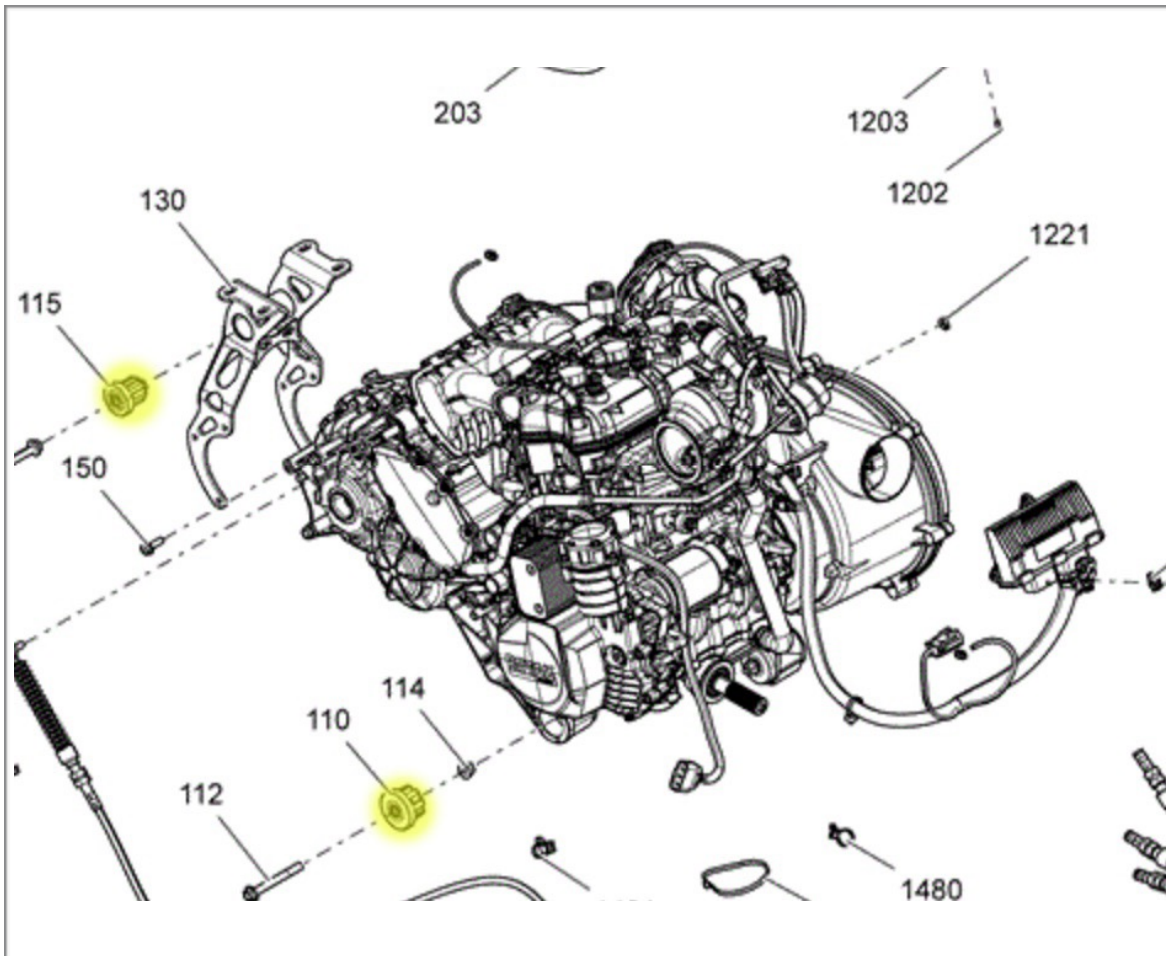

STEPS

- 1) Disconnect all items attached to motor. *See diagram below for reference.
- 2) Remove the motor and all attachments.
- 3) Remove four OEM motor mounts
- 4) Remove two OEM transmission mounts.
- 5) Install the new motor mounts in the appropriate holes and gently tap into position to ensure tight fitment.
- 6) Install the new transmission mounts in the appropriate holes and gently tap into position to ensure tight fitment.
- 7) Install the motor and all attachments.
