STEPS

1) Remove seat.

2) Unscrew and remove the airbox lid.

3) Remove the foam OEM seal from the airbox lid.

4) Clean any dirt or debris from where the previous foam OEM seal was on the airbox lid and around the airbox using a towel or alcohol pad.

5) Install the new o-ring / gasket around the airbox lid and ensure it is a tight fit.

6) Screw and install the airbox lid back into position.

7) Install seat back in position.
