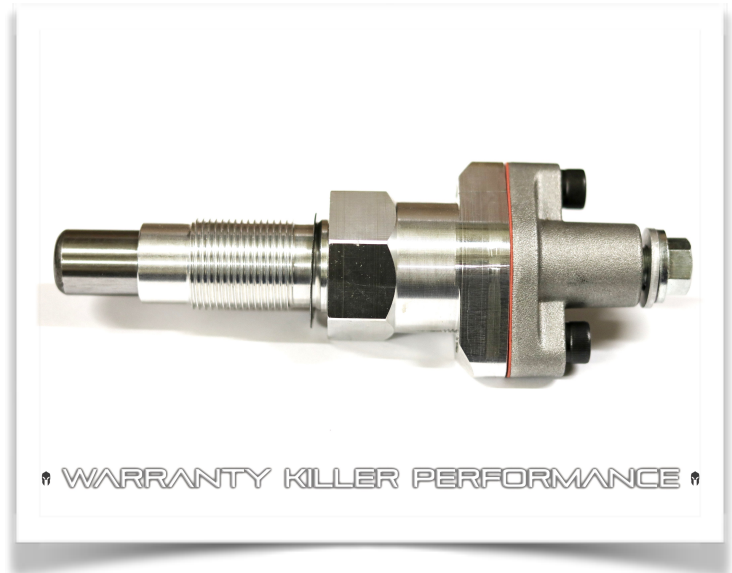
- x1 - M6 Allen Wrench
- x1 - 12MM Wrench
- x1 - 1-1/6" Wrench
- x1 - Towel

ESTIMATED INSTALL TIME

25 Minutes

STEPS

- 1) Remove valve cover.
- 2) Remove belt box CVT backplate cover and vent tube.
- 3) Rotate the engine counter clockwise, if not damage will occur. The engine will spin smoothly, if not you are spinning the wrong way and damage will occur.
- 4) Rotate the engine until it is top dead center. Horizontal marks will be shows on the gears and should all be aligned. The engine may spin past the top dead center but that is normal, the pressure should be relieved from the timing chain and you can continue the installation, if not rotate an additional 3-4 teeth which will release the pressure from all valve springs, if not damage may occur.
- 5) Remove the OEM tensioner using the 1-1/6" wrench.
- 6) Install new tensioner with dowel pins, gaskets and bolts. Tighten the two outside bolts on the tensioner using the M6 allen wrench.
- 7) Tighten the bolt with washer that is in the center of the tensioner using the 12mm wrench.
- 8) Install belt box CVT backplate cover, vent tube and valve cover.
