ESTIMATED INSTALL TIME

▶ 30 Minutes

STEPS

- 1) Remove belt box cover.
- 2) Spread secondary and remove CVT belt.
- 3) Remove old transmission input shaft seal with a seal puller. **Be careful to not dig into the inside diameter of the transmission case where the outside diameter of the seal mates with the transmission case to seal.**
- 4) Brake clean input shaft and transmission case of any dust, dirt or debris.
- 5) Apply grease to the o-ring and seal lip for easy press install, this will keep the o-ring and seal lips from rolling on install.
- 6) Slide the seal cover over the input shaft. Once at the transmission case make sure to press or tap the cover square as the interference fit for the o ring to seal the outside diameter is very precise.
