# **TOOLS NEEDED**

- Impact
- T30 Torx
- 17mm Socket
- 22mm Wrench
- · Preferred Punch (aluminum or brass)
- Hammer
- Can Am Secondary Clutch Roller Pin Removal Tool Part #: KWI-THCASCRPRT
- WKP Can Am Secondary Clutch Roller Pin Reamer Part #: WKP-CASCRPR
- OEM Secondary Clutch Spreader



#### **ESTIMATED INSTALL TIME**

• 1 Hour

# **STEP**

- 1) Remove belt box cover (T30 Torx).
- 2) Remove CVT belt (Can Am OEM Tool).
- 3) Remove secondary (17mm socket and impact).
- 4) Use OEM secondary spreader tool to take tension off secondary rollers.
- 5) Remove secondary roller pins with the Can Am Secondary Clutch Roller Pin Removal Tool only far enough to remove the OEM roller and install new HD roller with OEM washer reinstalled.
- 6) If using WKP Can Am Secondary Clutch Roller Pin Reamer, remove the pins all the way out of the secondary. Install reamer on drill insert in the first interference fit hole for the roller pin and spin the reamer one revolution, make sure you are true and square in the hole careful to not ream the hole out too much. This reamer is sized to make the existing hole .005" under sized of the pin to still have an interference fit but allow easy install since you are blind tapping the pin back through the washer and roller. This eliminates the chance of hitting the pin too hard and damaging the washer or roller upon install. Only ream the front first hole the pin passes through leave the back or furthest hole OEM fitment.
- 7) Using hammer and punch drive the pin back into the secondary square.
- 8) Check that your new WKP Can Am HD Secondary Rollers spin freely and reinstall all components removed.
- 9) Torque secondary to (45 ft lbs).
