

STEPS

- Disconnect all items attached to motor. *See diagram below for reference.
- 2) Remove the motor and all attachments.
- 3) Remove four OEM motor mounts.
- Remove OEM acetal spool, bolt and nylock nut using 1/2" socket.
- 5) Install the new motor mounts in the appropriate holes and gently tap into position to ensure tight fitment.
- 6) Install the new acetal spool using the provided bolt and nylock nut, tighten using 1/2" socket.
- Install the motor and all attachments.
