#### TOOLS NEEDED

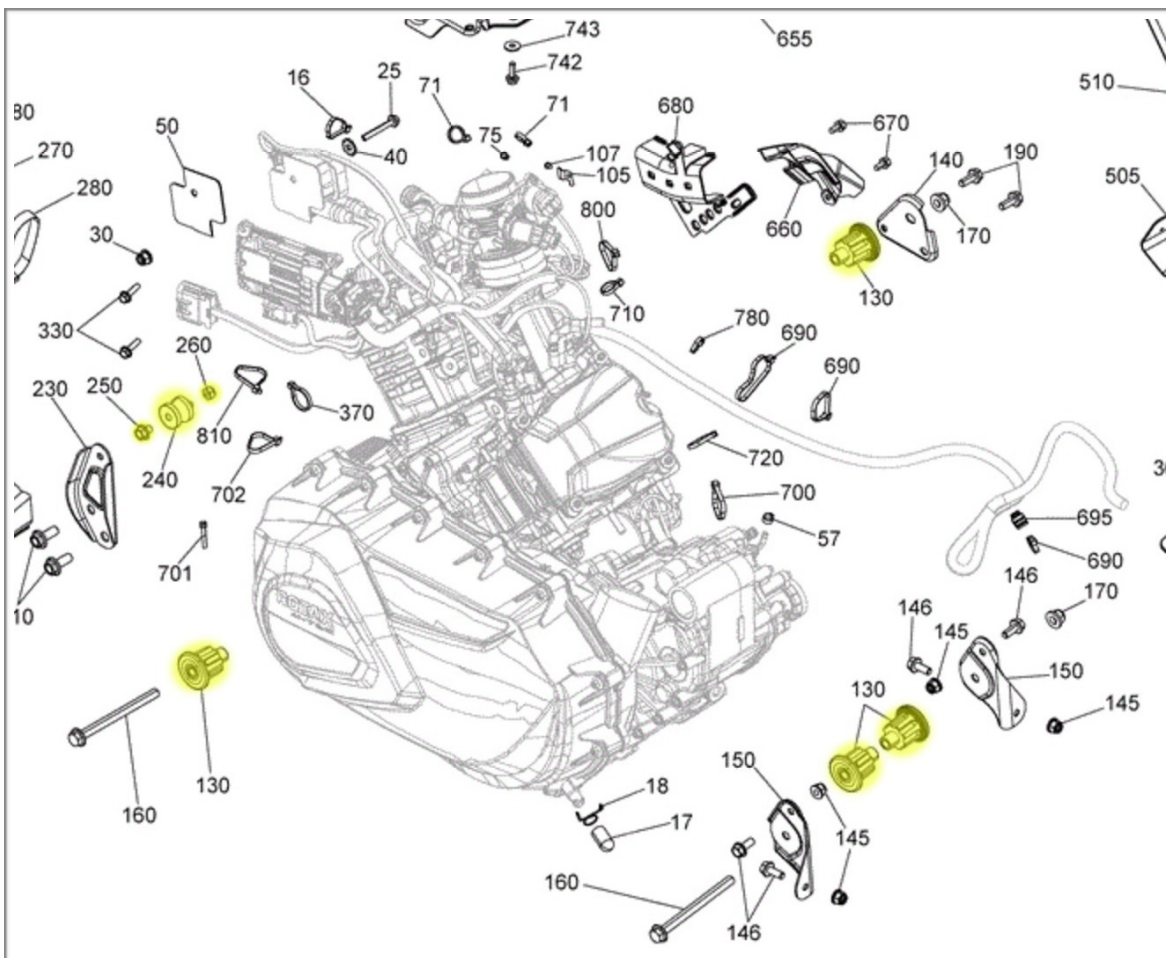
- 1/2" Socket
- Hammer / Malet

#### ESTIMATED INSTALL TIME

1.5 - 2 Hours

#### STEPS

- 1) Disconnect all items attached to motor. \*See diagram below for reference.
- 2) Remove the motor and all attachments.
- 3) Remove four OEM motor mounts.
- 4) Remove OEM acetal spool, bolt and nylock nut using 1/2" socket.
- 5) Install the new motor mounts in the appropriate holes and gently tap into position to ensure tight fitment.
- 6) Install the new acetal spool using the provided bolt and nylock nut, tighten using 1/2" socket.
- 7) Install the motor and all attachments.
