

**Crowder Shop #1 Sweepstakes
Official Rules**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT DOES NOT IMPROVE YOUR CHANCE OF WINNING.

1. **Eligibility:** The Crowder Shop #1 Sweepstakes (the "Promotion") is open only to legal residents 18 years of age or older of the 48 contiguous United States and the District of Columbia (excluding New York, Florida, Alaska and Hawaii) (the "Territory") who have reached the legal age of majority in their state of residence and are located in the Territory at the time of entry. Purchase transactions involving account adjustment transactions/returns, declined credit, or debit transactions are not eligible for Purchase Entries.
 - b. **Subscription Entry:** During the Promotion Period, visit any one of the Websites to register as a subscriber to receive "Subscription Entries". Monthly subscription cost is between \$9 and \$150 which is auto paid each month. Entrants must complete all required information. You must remain a subscriber for at least one month to earn Subscription Entries. RECEIVE TWO (2) ENTRIES FOR EACH \$1 SPENT FOR YOUR SUBSCRIPTION DURING THE PROMOTION PERIOD.
 - c. **Sign-up Entry:** During the Promotion Period, visit any one of the Websites, look for the pop-up form (the "Sign Up Form"), enter your mobile phone number and/or email address. - d. **Wellness Product or Limited Time Design Purchase Entry:** During the Promotion Period, visit any one of the Websites and purchase one or more “Wellness Products” or “Limited Time Design Products to receive entries into the promotion. Entrants must complete all required information. RECEIVE TWO (2) ENTRIES FOR EVERY \$1 USD SPENT ON WELLNESS or LIMITED TIME DESIGN PRODUCTS (not including tax and shipping). Purchase transactions involving account adjustment transactions/returns, declined credit or debit transactions are not eligible for Wellness Entries.
