
This course combines 3 nationally recognised units:

- 3. NAT11035002 Provide specialist body piercings

#### **Course Summary**

This course provides the skills and knowledge for individuals to work in body piercing and tattoo studios, clinics, parlours, salons, and shops.

It is designed to train students to safely offer body piercing in a professional clinic and have a thorough knowledge of sterilisation and cross-contamination issues. The course covers skills and knowledge to consult with and advise clients on jewellery and piercing sites, risk factors and self-care. Students



practice in a clinical environment to use body piercing equipment and provide a range of body piercings. There is a strong focus on maintaining infection control and understanding regulatory requirements.

#### **Career Pathway**

With this qualification you can seek employment in body piercing or set up your own practice in body piercing.

## **Course Duration**

4 full days of face to face in a classroom and clinical environment, plus online theory at your own pace.

Online theory remains live for 3 months post face to face training. Please see below for more information on extensions.

Most students take anywhere between 1 and 3 months to complete the online component, it is recommended you start your online training straight away.

**Course Delivery Mode** 

Blended both face to face training and online component.

#### **Course Prerequisites**

Students undertaking this course must hold a State of Attainment in HLTAID011 Provide First Aid.

Students need to be at least 18 years old in order to have sufficient maturity to advise on and provide body piercings.

Some mobile devices can be used to record and upload information as well as complete the online assessments.
