



## **ATHLETIC TEXTILES FOAM PADDED TURF LIMITED WARRANTY**

**ATHLETIC TEXTILES** extends the following limited warranty on the **ATHLETIC TEXTILES** foam padded and unitary short pile line of synthetic turf fabricated products (turf product only) to the **end user (property owner)** of the finished installed Turf Product only, subject to the conditions below. This limited warranty is effective for a period of five (5) years.

**ATHLETIC TEXTILES** further warrants the Turf Product fiber for five (5) years against (a) color fade in excess of 20 percent scale from the original color and (b) decreases in pile height in the finished Turf Product in excess of 50 percent from the original five. Color fading can be determined by examining the bottom portion of the fiber in relation to the top of the fiber. If the color of the Turf Product fiber in the finished Turf Product fades more than 20 percent or the pile height of the Turf Product fiber in the finished Turf Product decreases more than 50% due to ultraviolet radiation degradation within the stated time period, **ATHLETIC TEXTILES** will replace the affected portion of the finished Turf Product with new Turf Product of equal quality on a prorated basis.

**Fade Warranty** - applies to all turfs produced with a face weight of greater than 20oz.

**Wear Warranty** - applies to all turfs produced with a monofilament nylon face weight greater than 42oz.

**ATHLETIC TEXTILES** further warrants monofilament nylon turfs for 5 years against excessive wear resulting in excess of 50% loss or breakdown of turf fibers, due to wear and degradation during normal turf use. Wear warranty excludes pivot points and areas of impact, abuse or misuse of turf as intended for sports and athletics. Turf is not intended for use as weight room flooring and areas of heavy vertical impact.

The remedy of repair or replacement set forth herein shall be the only remedy. **ATHLETIC TEXTILES** warrants only the construction of the fabricated surface fiber system of the Turf Product and since **ATHLETIC TEXTILES** does not perform installations, we are not responsible for any installation failures. **ATHLETIC TEXTILES** obligations under this warranty are restricted to the replacement of the affected areas covered herein.

**ATHLETIC TEXTILES** shall have no other obligation or liability in any matter or thing, including without limitation, consequential damages, damages for personal injury or other damages of any type or kind. Failures resulting from the causes other than ultraviolet degradation of the face fiber yarn, such as; acts of GOD, damage due to **excessive heat, sun magnification**, faulty installation, removal or reduction of the fill system level, chemical attack from pool chemicals, burns, cuts, accidents, vandalism, abuse, negligence, neglect, herbicides, pesticides, acids, damage from adhesives, backing materials, cleaning agents, or any related causes are not covered by this warranty. Effects due to changes in texture resulting from application of entrapped dirt, normal wear, normal matting, traffic, and compression are expressly excluded from this warranty. All synthetic turf is subject to normal wear and tear. Normal wear and tear is not a manufacturing defect and is not covered by this warranty

**ATHLETIC TEXTILES** makes no warranty of final application usage other than those stated herein or by specific written agreement, and any warranties, expressed or implied, except the warranty expressly stated above, are excluded. **THE FOREGOING IS IN LIEU OF ALL OTHER WARRANTIES, STATUTORY, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. SPRINTSCAPE SHALL NOT, IN ANY EVENT, BE LIABLE FOR ANY INDIRECT, SPECIAL, INCIDENTAL, CONSEQUENTIAL, PUNITIVE OR OTHER SIMILAR DAMAGES INCLUDING, BUT NOT LIMITED TO, LOSS OF PROFITS OR REVENUE, GOODWILL OR OTHER ECONOMIC LOSS, EVEN IF ATHLETIC TEXTILES HAD BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.**

This Limited Warranty is not valid if not registered within thirty (30) days of installation. Purchaser must fill out the form below, detach it and mail it directly to **ATHLETIC TEXTILES** within the thirty (30) day time period. The Limited Warranty is effective between **ATHLETIC TEXTILES** and the end user at the time of purchase and is not transferable.
