INSTRUCTION MANUAL

CHARGING INDICATOR



CHARGING PORT

Plug the charging cable into the port on the back of the charging case and plug the other end into a 5v power source (standard mobile phone charger).

POWER BUTTON

Press and hold the power button for 3 seconds to turn on. Press firmly to cycle through the 10 settings. Press and hold for 3 seconds to power off.



CONNECT BUTTON

Press and hold the connect button for 3 seconds to turn on. If the wearable is on, the remote will automatically connect. Press firmly to cycle through the wearable's 10 settings. Press and hold for 3 seconds to power off.

INTERNAL MOTOR

for g-spot stimulation

DUAL EXTERNAL MOTORS

for clitoral stimulation



POWER BUTTON

Press and hold the power button for 3 seconds to turn on. Press firmly to cycle through the 10 settings. Press and hold for 3 seconds to power off.

HOW TO CONNECT



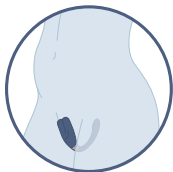
STEP 1:

To connect the wearable to the remote, press and hold the power button on the wearable for 3 seconds to turn on. On the remote, press and hold the connect button for 3 seconds to turn on. If the wearable is on, the remote will automatically connect.



STEP 2:

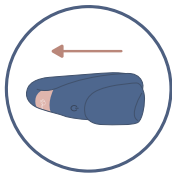
To hold the remote, slide the remote between two fingers. We recommend pressing the buttons with your thumb. Make sure the buttons are facing the inside of your hand and oriented towards the tip of your fingers.



STEP 3:

To wear the wearable, gently slide the back tail into the vagina until the front two prongs rest comfortably on both sides of the clitoris. The remote controls the wearable vibrations from up to 10 feet away.

HOW TO CHARGE



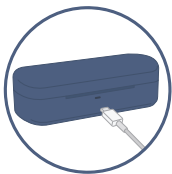
STEP 1:

Attach the remote to the wearable by sliding the remote between the two front prongs.



STEP 2:

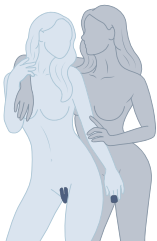
Place both components into the charging case so they fit within the mold. The wearable and remote can also be charged separately.



STEP 3:

Plug the charging cable into the port on the back of the charging case. Plug the other end into a 5V power source (standard mobile phone charger). The LED light on the case will pulsate slowly to indicate charging and turn solid when fully charged.

WAYS TO USE



WARM UP

Get in the mood with tandem masturbation. Use the remote as an independent vibrator on your partner while wearing the wearable.



EXPERIMENT

The remote opens the door to experimental partner play! Give your partner the power by letting them control the remote for an unpredictable and arousing foreplay experience.



GET THERE

Wear the wearable during penetrative sex. Allow the powerful vibrations to create shared pleasure for you and your partner inside and out.

CLEANING:

Be sure to clean thoroughly before and after each use. Clean using mild soap and warm water.

STORAGE:

Store in a cool, dry place separately from other sexual wellness devices; devices of different material can damage each other if left in contact.

QUALITY:

This product is manufactured using body-safe silicone that is harmless to the human body; free from phthalates, BPA and latex. Use water-based lubricant only.

CHARGING:

Do not turn on while charging and/or cleaning. While charging, the LED light on the charging case will pulsate slowly and turn solid when fully charged. Use only with 5-volt USB wall adapter (the standard mobile phone charger). Low battery alert: Lights on the wearable and remote will flash rapidly when battery is running low. Allow 90 minutes for a full charge. Total usage time from full battery on highest setting is 50 minutes.

WARNINGS:

Discontinue use if there is any discomfort for you or your partner. Do not expose device to water while charging.

WATERPROOF:

The wearable and remote are waterproof to IPX7 standards and can be submerged in the bath or shower. Do not expose the charging case to water.
