

FITNESS EQUIPMENT WARRANTY INFORMATION

Temple of Gainz brand fitness equipment products sold and distributed by **Temple of Gainz, LLC** are backed by the added security of our warranty, where indicated. We warrant that your product will be free of defects in material or workmanship under normal use and cared for according to the product instructions during the product's warranty period. Please note that the warranty period begins from the date of retail purchase by the original end-user purchaser. The warranty only covers authorized purchases made directly from Temple of Gainz.

The warranty period for all products is indicated on the following chart. Minor imperfections and slight color variations should be considered normal. This warranty excludes damage to the product from misuse or abuse, such as improper cleaning, neglect, accident, alteration, fire, theft, or acts of God. In the unlikely event that your product becomes defective during the warranty period, at our discretion, we will provide replacement parts for your product at no charge.

A copy of your dated proof of purchase may be required prior to any claims under our warranty. We reserve the right to request photographic or videographic proof of product defect(s), and request that the defective product in question be shipped to us to verify the defect, repair the defect, or to aid in quality control efforts.

Your product has been manufactured to strict specifications and has been designed for use with authorized replacement parts. This warranty expressly excludes any defect(s) or damage(s) caused by accessories, replacement parts, and/or repair services other than those authorized by Temple of Gainz, LLC. Specially discounted merchandise may not be covered by our warranty. This warranty is valid only in the country where the product was purchased.

The following are not covered by our warranty, but not limited to:

- Dents, scratches, and other conditions to the product that occur over time, otherwise considered as normal wear and tear.
- Misuse, abusive use, or intentional damage to the product.
- Accidents to the product.
- Modifications or alterations to the product.
- Incorrect operation, installation, or not following the operation instructions.
- Non-product authorized parts.
- Prolonged periods of dampness or condensation
