RELEASE & WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

READ THIS AGREEMENT CAREFULLY BEFORE SIGNING IT. Your signature indicates that you understand and agree to the terms and conditions contained herein. By signing this agreement, you (and your minor child[ren]) are giving up certain legal rights. These include the right to sue or to recover damages in case of injury, death, disease, or property damage for any reason including but not limited to the negligence of the La Pine Rodeo Association, its owners, agents, employees, officers, board of directors, members, volunteers, representatives, assigns, sponsors, affiliated organizations, attorneys, insurers and others acting on its behalf.

In consideration of the risk of injury in handling animals, riding horses or other livestock, or participating in any way with the La Pine Rodeo Association (the "Activities"), and as consideration for the right to participate in the Activities, I hereby, for myself, my heirs, executors, administrators, personal representatives, and minor child(ren), knowingly and voluntarily enter into this waiver and release of liability and hereby waive any and all rights, claims or causes of action of any kind whatsoever arising out of my participation in the Activities, and do hereby release and forever discharge the La Pine Rodeo Association, its owners, agents, employees, officers, board of directors, members, volunteers, representatives, assigns, sponsors, affiliated organizations, attorneys, insurers and others acting on its behalf, for any physical or psychological injury, including but not limited to illness, paralysis, death, damages, economical or emotional loss, that I may suffer as a direct result of my participation in the aforementioned Activities, including traveling to and from an event or the La Pine Rodeo Association grounds related to these Activities.

1. I, _____, hereby acknowledge that the aforementioned Activities are inherently dangerous and may result in serious injury and/or death. Horses/mules and livestock may, without warning or any apparent cause, buck, stumble, trip, roll, fall, rear, bite, kick, run, become startled or surprised, make severe and unpredictable movements, spook, jump over obstacles and fences, step on a person's foot, push or shove a person, run a person into a wall or side rail, etc. Additionally, I understand that saddles and bridles may loosen or break which may result in serious injury and/or death.

2. I, _____, hereby voluntarily assume the risk and danger of injury and/or death inherent in riding a horses, mules, or other livestock because of their unpredictable nature and irrational behavior regardless of their training, guidance, and past performance.

3. I, _____, hereby agree to release and forever discharge and promise not to sue the La Pine Rodeo Association, its owners, agents, employees, officers, board of directors, members, volunteers, representatives, assigns, sponsors, affiliated organizations, attorneys, insurers and others acting on its behalf for personal injury, death, or property damage arising out of the aforementioned Activities.

4. I, _____, hereby release the La Pine Rodeo Association, its owners, agents, employees, officers, board of directors, members, volunteers, representatives, assigns, sponsors, affiliated organizations, attorneys, insurers and others acting on its behalf from any claim that any person was negligent in connection with my or my child's riding of any horse, mule or other livestock including but not limited to any training, selection of horse, mule or livestock and any claim of negligence in the maintenance, care, fit or adjusting of any saddles, bridles or other equipment or any instruction or explanation on riding skills or leading or supervising riders which resulted in personal injury, loss, damage, injury, or death.

5. I, _____, hereby agree to indemnify and hold harmless the La Pine Rodeo Association, its owners, agents, employees, officers, board of directors, members, volunteers, representatives, assigns, sponsors, affiliated organizations, attorneys, insurers and others acting on its behalf from and against any loss, liability, damage or cost that may incur arising out of or in any way connected to my or my minor child's handling or riding of a horse, mule or other livestock and/or resulting from the use of any saddles, bridles, equipment or gear provided by the La Pine Rodeo Association.

6. I, _____, hereby expressly agree that the foregoing Release & Waiver of Liability and Assumption of Risk and Indemnity Agreement is governed by the laws of the State of Oregon and is intended to be as general, broad and inclusive as possible permitted by Oregon Law. In the event any portion of this agreement is determined to be invalid or unenforceable for any reason, the balance of this agreement shall not be affected or impaired in any way and shall continue in full legal force and effect.



7. I, _____, hereby acknowledge that this document is a contract for valuable consideration and I agree that if a lawsuit is filed against the La Pine Rodeo Association, any of its agents, employees, volunteers, officers, board of directors, owners, and all others connected herewith for any injury or damage in breach of this contract I will be responsible for paying all attorney fees together with court costs both at trial and upon any appeal in defending any such action.

8. I, _____, hereby understand and acknowledge that it is recommended that I myself, my minor child(ren) and all other riders wear a properly fitted and secured protective helmet that is certified by ASTM/SEI Equestrian standards, while riding or being around horses or mules in order to potentially reduce the severity of possible head injuries or potentially prevent death from occurring. I understand that my minor child(ren) are required to wear a protective helmet and are not allowed to refuse this safety measure nor am I allowed to sign on their behalf to refuse this safety measure.

My initials below indicate that I understand the recommendation to wear a helmet but I myself am refusing this safety measure for myself personally as an adult:

I UNDERSTAND THAT IT IS A PROMISE NOT TO SUE AND TO RELEASE LA PINE RODEO ASSOCIATION, ITS OWNERS, AGENTS, EMPLOYEES, OFFICERS, BOARD OF DIRECTORS, MEMBERS, VOLUNTEERS, REPRESENTATIVES, ASSIGNS, SPONSORS, AFFILIATED ORGANIZATIONS, ATTORNEYS, INSURERS AND OTHERS ACTING ON BEHALF, FROM ALL CLAIMS. I HAVE MADE A FREE AND DELIBERATE CHOICE TO SIGN THIS RELEASE, WAIVER AND ASSUMPTION OF RISK AND INDEMNITY AGREEMENT. I AM SIGNING THIS AGREEMENT FREELY AND VOLUNTARILY. I HAVE BEEN ADVISED TO SEEK MY OWN INDEPENDENT LEGAL ADVICE AT MY OWN EXPENSE PRIOR TO SIGNING THIS CONTRACT.
