In consideration of the risk of injury in handling animals, riding horses or other livestock, or participating in any way with the La Pine Rodeo Association (the "Activities"), and as consideration for the right to participate in the Activities, I hereby, for myself, my heirs, executors, administrators, personal representatives, and minor child(ren), knowingly and voluntarily enter into this waiver and release of liability and hereby waive any and all rights, claims or causes of action of any kind whatsoever arising out of my participation in the Activities, and do hereby release and forever discharge the La Pine Rodeo Association, its owners, agents, employees, officers, board of directors, members, volunteers, representatives, assigns, sponsors, affiliated organizations, attorneys, insurers and others acting on its behalf, for any physical or psychological injury, including but not limited to illness, paralysis, death, damages, economical or emotional loss, that I may suffer as a direct result of my participation in the aforementioned Activities, including traveling to and from an event or the La Pine Rodeo Association grounds related to these Activities.
