1. Consignment Terms

The Consignor agrees to deliver to the Consignee the following items for sale on a consignment basis: ***Sports and Trading Cards – Consignor agrees to provide inventory list and or/photos at time of submission***

2. Pricing and Payment

- The Consignee shall sell the consigned goods using mutually agreed upon sales channels such as eBay, Whatnot, card shows and social media.
 - The consignor understands that sales made on Whatnot and eBay will be auctions and will start at \$1.00. The consignee takes no responsibility in the final prices the cards will sell at.
- The Consignee shall retain a percentage % of the sale price as a commission minus all associated fees such as listing fees, credit card fees, and platform fees (eBay, Whatnot, etc) which is defined as NET SALES as follows:
 - \$1-\$150: 75% of Net Sales Price to consignor
 - \$151-\$999.99: 78% of Net Sales Price to consignor
 - \$1000-\$2499.99: 85% of Net Sales Price to consignor
 - \$2500 or more: 90% of Net Sales Price to consignor

Example of Net Sales Calculation:

Card sales price on Whatnot =	\$100
Credit Card and transaction fee =	3% plus \$.30
Platform Fee =	8%
Net Sales Price =	\$88.70

- The Consignor shall receive payment for sold items no later than **3 days** after sale.

3. Responsibilities of the Parties

- The Consignor retains ownership of the consigned goods until they are sold.

- The Consignor will ship all sports and trading cards to be consigned at their cost to our office or deliver by hand during normal business hours
- The Consignor agrees that only cards of **\$25 value** or greater qualify for consignment.
- The Consignor agrees to prepare the cards for resale before shipment by placing them in **new one touch magnetic cases**. If they are not shipped resale ready there is an additional \$2.50 per card charge for labor and materials.
- The Consignee agrees to use reasonable efforts to sell the items and maintain them in good condition.
- The Consignee shall provide sales reports to the Consignor upon request.

4. Unsold Items

- Unsold items shall be returned to the Consignor at their cost or be forfeited to the consignee upon mutual agreement by both parties.
- The Consignee shall not be liable for damage or loss except in cases of negligence.

5. Termination

This Agreement may be terminated by either party with 30 days written notice. Upon termination, all unsold items must be returned to the Consignor.

6. Governing Law

This Agreement shall be governed by the laws of Texas, Collin County

7. Entire Agreement

This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements or understandings, whether written or oral.
