PRIVACY NOTICE

This website is operated by Polysciences, Inc. The terms "we", "us", and "our" used in this Privacy Notice refer to Polysciences, Inc. We are committed to protecting the personal information that you provide to us through this website. This Privacy Notice is designed to help you understand how we collect, use, share, and safeguard the personal information you share with us and to assist you in making informed decisions when you visit and use our website.
