## **BEFORE ASSEMBLY**

- 1. Do not assemble this product without following the instructions carefully. Proper and complete assembly, use, and supervision are essential for proper operation and to reduce the risk of accident or injury. Failure to properly install, maintain, and operate this product can result in serious injury or death to the equipment user.
- 2. Before beginning assembly, inspect all parts and hardware. Ensure all parts are included by referencing the chart in the assembly instruction.
- 3. Two (2) adults are recommended for setup.
- 4. To prevent serious injury, children must not use the equipment until properly installed. Always keep safety in mind as your structure is being built.
- 5. Prepare a level surface with the proper safety zone (see Installation Instructions and Ground Preparation Instructions).
- 6. Warning, this product is only for domestic/residential use. gobaplay does not warranty any residential structures subjected to commercial use, such as Daycare, Preschool, Nursery School, Recreational Park, or any similar Commercial Application.
- 7. Keep these instructions for future reference.

## **OPERATOR INSTRUCTIONS**


Observing the following statements and warnings reduces the likelihood of serious or fatal injury.

- 1. Most injuries are caused by misuse and/or not following instructions. Use caution when using this product.
- 2. The owner must ensure that all users know and follow these rules for safe operation.
- 3. A maximum of 250 lbs (114 kg) per child is recommended for play activities designed for individual use. A maximum of 125 lbs (57 kg) per child is recommended for play activities designed for multiple child use. A maximum of two (2) children is recommended for this product.
- 4. On-site adult supervision is required for children of all ages.
- 5. Instruct children not to walk close to, in front of, behind, or between moving items.
- 6. Instruct children not to twist swing chains or ropes or loop them over the top support bar, as this may reduce the strength of the chain or rope.
- 7. Instruct children to avoid swinging empty seats.
- 8. Teach children to sit in the center of the swings with their full weight on the seats.
- 9. Instruct children not to use the equipment in a manner other than intended.
- $10.\,$  Instruct children not to get off equipment while it is in motion.
- 11. Do not allow children to wear inappropriate items such as, but not limited to, loose-fitting clothing, hood and neck drawstrings, scarves, cord-connected items,

- capes, and ponchos. These items can cause death by strangulation.
- 12. Instruct children not to climb or play when the equipment is wet.
- 13. Verify that suspended climbing ropes, chains, or cables are secured at both ends and cannot be looped back on themselves.
- 14. Instruct children not to attach items to the playground equipment that are not specifically designed for use with the equipment, such as, but not limited to, jump ropes, clotheslines, pet leashes, cables, and chains, as they may cause a strangulation hazard.
- 15. Instruct children to remove their bike or other sports helmet before playing on the playground equipment.
- 16. Dress children in well-fitting and full foot-enclosing footwear. Examples of inappropriate footwear are clogs, flip-flops, and sandals.
- 17. Never add extra length to the chain or rope. The chains or ropes provided are the maximum lengths designed for the swinging element(s). Maintain a minimum clearance of 8 in. (205 mm) [in EU countries, 14 in. (350 mm)] from the ground.
- 18. Owners shall be responsible for maintaining the legibility of the warning labels.

## **INSTALLATION INSTRUCTIONS**

- 1. Place the equipment on level ground to minimize ground preparation and reduce the likelihood of this product tipping over and loose-fill surfacing materials washing away during heavy rains.
- 2. Position this product not less than 79 in. (2 m) from any structure or obstruction such as a fence, garage, house, overhanging branches, laundry lines, or electrical wires.
- 3. The SAFE PLAY ZONE refers to a zone extending 79 in. (2 m) beyond the play product on all sides, including the space above the play product. The MAXIMUM FALL HEIGHT refers to the vertical distance between the top of the designated play surface and the protective surfacing below.

4. Place your equipment in an area convenient for adult supervision.



- 5. Do not install home playground equipment over concrete, asphalt, packed earth, grass, carpet, or any other hard surface. A fall onto a hard surface can result in serious injury or death to the equipment user.
- 6. Create a site free of obstacles that could cause injuries, such as low overhanging tree branches, overhead wires, tree stumps or roots, large rocks, bricks, and concrete.
- 7. Ensure the clearance in front of and behind the swings is at least twice the height of the swing bar.
- 8. Pay special attention to plastic and metal surfaces in direct sunlight, as they may be hot enough to cause burns. Always check the temperature of the product before letting your children play.
- 9. This product must be anchored to prevent tipping, overturning, or lifting during use. Anchors are sold separately. Anchoring devices must be installed through the anchoring holes at the base of the frames. Note that anchoring devices must be placed below the level of the playing surface to prevent tripping or injury resulting from a fall. Do not install this product on surfaces with sandy soil conditions.

## **GROUND PREPARATION INSTRUCTIONS**

- 1. This product should not be built on top of surfacing.
- 2. Do not apply playground surfacing until after the unit is completely constructed.
- 3. All surface material should extend a minimum of 79 in. (2 m) feet in all directions around the play area.
- 4. The maximum fall height for this product is 96.1 in. (2.44 m). The following chart explains the fall height from which a life-threatening head injury would not be expected:

\*This data is from tests conducted by independent testing laboratories on a 6 in. (153 mm) depth of uncompressed shredded tire samples produced by four manufacturers. The tests reported critical heights ranging from 120 in. (3 m) to greater than 144 in. (3.7 m). It is recommended that persons seeking to install shredded tires as a protective surface request test data from the supplier showing the critical height of the material when it was tested per ASTM F1292.


One of the most important things you can do to reduce the likelihood of serious head injuries is to install shock-absorbing protective surfacing under and around your play equipment. The protective surfacing should be applied to a depth that is suitable for the equipment height in accordance with ASTM Specification F1292. There are different types of surfacing to choose from; whichever product you select, follow these guidelines:


#### 1. Loose-Fill Materials:

- Maintain a minimum depth of 9 in. (229 mm) of loose-fill materials such as wood mulch/chips, engineered wood fiber (EWF), or shredded/recycled rubber mulch for equipment up to 96 in. (2438 mm) high; and 9 in. (229 mm) of sand or pea gravel for equipment up to 60 in. (1524 mm) high. NOTE: An initial fill level of 12 in. (305 mm) will compress to about a 9 in. (229 mm) depth of surfacing over time. The surfacing will also compact, displace, and settle, and should be periodically refilled to maintain at least a 9 in. (229 mm) depth.
- 2. Use a minimum of 6 in. (152 mm) of protective surfacing for play equipment less than 48 in. (1219 mm) in height. If maintained properly, this should be adequate. (At depths less than 6 in. (152 mm), the protective material is too easily displaced or compacted.) NOTE: Do not install home playground equipment over concrete, asphalt, or any other hard surface. A fall onto a hard surface can result in serious injury to the equipment user. Grass and dirt are not considered protective surfacing because wear and environmental factors can reduce their shock absorbing effectiveness. Carpeting and thin mats are generally not adequate protective surfacing. Ground level equipment such as a sandbox, activity wall, playhouse or other equipment that has no elevated play surface does not need any protective surfacing.
- 3. Use containment, such as digging out around the perimeter and/or lining the perimeter with landscape edging. Don't forget to account for water drainage.
  - Check and maintain the depth of the loose-fill surfacing material. To maintain
    the right amount of loose-fill materials, mark the correct level on play equipment support posts. That way you can easily see when to replenish and/or
    redistribute the surfacing.
  - Do not install loose fill surfacing over hard surfaces such as concrete or asphalt.



- 4. Poured-In-Place Surfaces or Pre-Manufactured Rubber Tiles—You may be interested in using surfacing other than loose-fill materials like rubber tiles or poured-in-place surfaces.
  - Installations of these surfaces generally require a professional and are not "do-it-yourself" projects.
  - Review surface specifications before purchasing this type of surfacing. Ask the installer/manufacturer for a report showing that the product has been tested to the following safety standard: ASTM F1292 Standard Specification for Impact Attenuation of Surfacing Materials within the Use Zone of Playground Equipment. This report should show the specific height for which the surface is intended to protect against serious head injury. This height should be equal to or greater than the fall height vertical distance between a designated play surface (elevated surface for standing, sitting, or climbing) and the protective surfacing below of your play equipment.
  - Check the protective surfacing frequently for wear.
- 5. Placement—Proper placement and maintenance of protective surfacing is essential. Be sure to:
  - Extend surfacing at least 72 in. (2 m) from the equipment in all directions.
  - For to-fro swings, extend protective surfacing in front of and behind the swing to a distance equal to twice the height of the top bar from which the swing is suspended.
  - For tire swings, extend surfacing in a circle whose radius is equal to the height of the suspending chain or rope, plus 6 ft in all directions.

## **MAINTENANCE INSTRUCTIONS**

If routine checks and maintenance procedures are not done, the equipment could overturn and/or become a hazard.

#### AT THE BEGINNING OF EACH PLAY SEASON:

- 1. Tighten all hardware.
- 2. Lubricate all metallic moving parts.
- 3. Check all protective coverings on bolts, pipes, edges and corners. Replace if they are loose, cracked or missing.
- 4. Check all moving parts, including swing seats, ropes, cables and chains for wear, rust or other deterioration. Replace as needed.
- 5. Check metal parts for rust. If found, sand and repaint using a non lead-based paint meeting the requirements of 16 CFR 1303.
- 6. Reinstall any plastic parts, such as swing seats or any other items that were removed for the cold season.
- 7. Rake and check depth of loose fill protective surfacing materials to prevent compaction and to maintain appropriate depth. Replace as necessary.

#### TWICE A MONTH DURING PLAY SEASON:

- 1. Tighten all hardware.
- 2. Check all protective coverings on bolts, pipes, edges and corners. Replace if they are loose, cracked or missing.
- 3. Rake and check depth of loose fill protective surfacing materials to prevent compaction and to maintain appropriate depth. Replace as needed.

#### ONCE A MONTH DURING PLAY SEASON:

- 1. Lubricate all metallic moving parts.
- 2. Check all moving parts including swing seats, ropes, cables, and chains for wear, rust, or other deterioration. Replace as needed.

# AT THE END OF EACH PLAY SEASON OR WHEN THE TEMPERATURE DROPS BELOW 40°F (5°C):


Rake and check depth of loose fill protective surfacing materials to prevent compaction and to maintain appropriate depth. Replace as necessary.




**WARNING** - Use the tools provided to tighten the bolts. Do not over-tighten. The use of power tools may cause severe damage to the frame.

- Lay out the parts as shown.
- If you are missing any parts, please get in touch with gobaplay.



**NOTE** - This swing is designed for use on a swing set with sufficiently strong swing hooks and a nylon bearing. This swing does not include mounting hardware for any other type of installation.

**WARNING** - Do not remove the foam padding from the frames.

• Unfasten the four fabric flaps and assemble the **(B)** and **(C)** frames, as shown.




**NOTE** - The end frames have been pre-installed to simplify the assembly process. Do not try to remove these frames because reassembly is very difficult.

**NOTE** - Certain images contain parts that have been colored yellow. This is meant to bring attention to a specific assembly step and may not represent the actual color of the parts.








- Slide the connected side frames through the long pockets on the platform swing.
- Then, fit the ends of the frames into the pre-installed frames.
- When all of the frames are assembled, the holes at the ends of the frames will be aligned at the four unfastened loops.





- Thread the end of the ropes with the bolts, nuts and washers down through the top of the unfastened loops.
- Unfasten the nut, spring washer, and one washer and fit the bolt through the hole in the joined frames. Be sure that you have one washer above the frame.
- Refasten the washer, spring washer, and then the nut and tighten it with the wrench provided.
- Repeat this process at each corner and, when finished, fasten the four fabric flaps down in place.





**NOTE** - Swing set frames are sold separately. Refer to your swing set's assembly instructions, safety precautions, and warnings before use.



**WARNING** - When adjusting the swing height, maintain a minimum clearance of 8 in. (205 mm) [in the UK and EU countries, 14 in. (350 mm)] from the ground. No one should sit on the swing while making adjustments. After adjusting the ropes, ensure the swing is level. Unequal rope lengths will cause an unsafe circular pendulum motion during use.

- Hang the swing from a suitable swing frame or structure using the metal rings at the end of the ropes.
- Push or pull the rope through the metal adjustment loops to adjust the height until the swing is at a safe swinging level.
- Congratulations! You have successfully installed your platform swing set. Have fun!
