

WHAT ARE YOUR OPTIONS AND

There are different routes to achieving your goal of strengthening NAASR's programs for the advancement of Armenian Studies. We are willing to work with you and your estate planners to discuss possibilities.

Bequests

Making a bequest to NAASR is as easy as can be but it will have a far-reaching impact. All that is necessary is to include language in your will. Since NAASR is a non-profit organization, bequest will benefit your estate in that it lowers the taxable value of your estate and is exempt from state inheritance taxes.

You may bequeath either a percentage of your estate or a specific dollar amount. Talk to your estate planner about which is the better option for you.

A bequest can be designated for a specific purpose or it may be left unrestricted, thus providing NAASR with the flexibility to utilize the funds for future purposes that may not today be readily apparent.

Sample Bequest Language: "I give, bequeath, and devise to the National Association for Armenian Studies, Inc., located in Belmont, Massachusetts, the sum total of \$\frac{1}{2} \text{ X percent as a gift from my estate."}

LIFE INSURANCE

You can donate a paid-up life insurance policy no longer needed by your family and receive a tax benefit or revocably name NAASR as the beneficiary of a life insurance policy which you will continue to own.

PROPERTY

A gift called a retained life estate allows you to donate real estate to NAASR and retain the use of the property during your life.

LIFE INCOME GIFTS

This method of giving allows you to give during your lifetime, derive income from the gift as well as tax benefits. A charitable gift annuity or charitable remainder trust may be desirable options for you to explore.

RETIREMENT ASSETS


Giving an IRA, 401(k), or 403(b) can be an attractive choice. These accounts are among the highest taxed assets in your estate. By bequesting them to a non-profit such as NAASR, we will receive the full amount of the gift at no cost to you during your lifetime and your heirs will receive more of your estate by receiving more favorably taxed assets.
