Wholesale Terms at a Glance:

- o Wholesale Discount: 40% off Retail price.
- o Items must be sold in the Kindred Stamps packaging.
- o Minimum Order: \$100. Minimum Qty: 4 of 1 set.
- o Invoices will be emailed at the same time as your order total and approximate shipping date is provided. Payment must be received prior to order shipping.
- o Stamps are allowed to be sold at sale prices no more than 4 times per calendar year for 1 week at a time. Maximum discount allowed is 20%.

Ordering/Shipping:

- o To place your wholesale order, please complete the wholesale order form and email to audra@kindredstamps.com.
- o We will respond within 2 Business Days with invoice showing your order total with shipping and the approximate shipping date.
- o Processing time will be dependant on our in stock levels.
- o Shipping costs will be determined on your order size and will be shipped Priority Flat Rate with insurance.



Wholesale Account Application

By submitting this application you agree to abide by our wholesale program terms.

Once accepted as a Kindred Stamps wholesale distributor, you may sell our items only on your website or brick and mortar location listed on your application. As a wholesale distributor, you cannot list our items for sale on Etsy, Ebay, Amazon, any Social Media website such as a business or personal facebook page, destash group, third party website etc.

Upon being accepted as a wholesale distributor you will receive a 40% discount off our listed retail price. Any stamps on sale or clearance are eligible for a wholesale discount, but you will receive 40% off the original retail price, NOT the already discounted price. Wholesale order minimums are \$100, and our required minimum quantity is 4 per set.

To place a wholesale order please complete the wholesale order form and email to hello@kindredstamps.com. We will send you an invoice via the email provided within 2 business days with your order total and shipping costs. Invoices must be paid within 5 business days. Orders will not ship until payment is completed. No refunds are accepted on shipped orders. Cancellations are accepted with a 95% refund as long as the order has not shipped.

Any new release stamp set is available for purchase at wholesale pricing after it has been listed on the Kindred Stamps website for 20 days. Any listings, social media, marketing, etc must only refer to the stamp names, and not any character or properties they may be similar to.

As a wholesale distributor, you agree that our stamps will be sold in their original packaging as you receive them. Kindred Stamps products as a whole are allowed to be sold at sale prices no more than 4 times per calendar year for up to 1 week at a time. The maximum discount allowed on Kindred Stamps products during these sale periods is 20%. Wholesale orders are not eligible to receive reward points through the Kindred Stamps reward program.

Shipping is done through USPS Priority flat rate shipping. Once your order form is processed you will receive a detailed invoice to your email that includes the shipping cost. All invoices must be paid prior to your order shipping. Please be aware that while your package will be insured, we ask that you have your package sent to a secure location. Once the package is marked as delivered, we are not able to open an insurance claim through the USPS. Having a secure mail location can help prevent theft and lost packages.

We accept wholesale account applications from the United States as well as internationally. Please be aware that there may be duties, taxes, brokerage fees, clearance fees etc through your postal service. Kindred Stamps is not responsible for these fees. If any international package is refused for any reason, all shipping costs or fees due will be deducted from the refund owed to you once we receive the package returned to us.
