PHOTOGRAPHY SERVICES AGREEMENT

This Agreement for Photography Services ("Agreement") is entered into between **Name and Name** referred to as "Client," and Kay and Derek Kroshus and/or second shooter, referred to as "Photographer."

SERVICES

IMAGES: Photographer shall provide photographic services, for Client's event. Unless otherwise noted, photographs will be taken using digital camera equipment, producing digital images in high-resolution, JPG format. Client will receive the number of edited images included in the collection chosen by Client. Photographer will use his/her professional judgment to determine which images will be included. Photos may contain a mixture of color, and black and white images. The photographer's editing process will consist of color correction, light and natural skin softening, and adding a filter consistent to what is shown in the Photographer's portfolio. Additional touchups such as object or blemish removal, heavy skin softening, head swapping, or altering the subject or scene in any way is not included, but may be made available at an additional charge. The edited JPG images will be the only photos made available to Client. The RAW, unedited images are not an accurate representation of the Photographer's work and will not be available to the Client. Images will be edited and completed within 6-8 weeks of the event. Unless otherwise agreed upon, digital images will be delivered to Client electronically over the internet (an internet photo gallery site). Photos will be taken offline one year after the event.

COVERAGE: Photographer will provide coverage for the dates, locations, and hours specified in the collection chosen by Client and specified in Agreement. Photographer may use additional assistants. Additional hours of coverage may be added for an additional fee. If additional hours are added prior to the day of the wedding, such agreement shall be in writing. If additional hours are added on the day of the wedding, an oral agreement for additional coverage shall be binding on both parties. If agreed upon, on the wedding day, overtime hours may be added for an additional fee. Photographer and assistant(s) are entitled to a 30 minute break during the reception while guests are dining. This time is included in the hours specified.

RESPONSIBILITIES: All involved parties agree to cooperate for the best possible results. While every attempt will be made to accommodate Client's desired photographs and to create the best images possible, no particular image is guaranteed. It is the responsibility of Client or a designee to point out individuals/groups that are important to have photographed and to ensure that key individuals are available and prepared to be photographed. If Client or key individuals fail to appear at meeting place by scheduled time, they will not receive full time of shooting. To ensure Photographer has enough time to take photographs discussed, and to acquire group and couple shots, Client must provide at least a 1-hour time slot after the ceremony. Videographers, vendors, and guests must not interfere with the official photography. These individuals are not permitted to take any still shots during formal sessions. Wedding guests may take photos, however, it is Client's responsibility to ensure they don't interfere with Photographer's duties. Client agrees to confirm the schedule one week prior to the event. If any changes arise in the schedule or location, Client must notify Photographer in a timely manner, by email for documentation. Photographer will acknowledge changes and Client must obtain confirmation of receipt.

FEES/EXPENSES

MANDATORY RETAINER: To reserve your date, a retainer totaling \$3000 for a full wedding collection, or \$1000 for the elopement collection is due upon signature of Agreement. This is to book the specified date of the event and is NON-REFUNDABLE. Full payment is due two weeks prior to the event.

EXPENSES: Client agrees to pay the fees set forth below. Client shall pay food and beverage for Photographer and assistant(s) during the event. If the event takes place outside Photographer's service area, additional travel fees will be assessed. Digital images will not be provided to Client until full payment has been made.

RETURNED CHECKS: If any check offered by Client to Photographer in payment of any amount due under this Agreement is returned for lack of sufficient funds, a "stop payment" or for any other reason, Client will pay Photographer a returned check charge of \$ 25 plus any fees assessed by Photographer's banking institution as a result of the returned check.

OTHER SERVICES: This contract is for photography services and delivery of digital images only, and any products specified in the collection chosen by Client. Additional services, such as prints and products are available as a separate order. Additional touch-ups are also available as a separate order. Prices are subject to change at any time.

LIMITATION OF LIABILITY

EVENT: In the event Photographer is unable to perform the duties stated in Agreement for any unforeseen reasons or circumstances beyond his/her control, an attempt will be made to obtain the services of another professional photographer to fulfill the obligations of Photographer. If Photographer is unable to secure such services, all fees will be returned including the initial deposit. If Photographer's assistant is unable to perform duties, his/her fees will be refunded to Client. Photographer cannot be held responsible for compromised coverage beyond his/her control such as, but not limited to, a guest's camera flash, schedule conflicts, restrictions of the officiate or venue, weather conditions, or existing backgrounds and lighting conditions which may restrict the photography coverage and negatively impact the images.

SAFETY: Client has the right to refuse any pose or location. It is the responsibility of Client and wedding guests to refuse to stand or be placed in any position or location where they feel uncomfortable or endangered. If Client and guests agree to stand or be placed in any position or location during the session, they assume all risks associated with the position and location. Photographer will not be responsible for any personal injury and/or property damage that might result from Client being injured during the event and related sessions.

IMAGES: Entire liability for any theft, loss, injury or failure to deliver digital images, is limited to the return of any fees paid by Client under this contract. Once the images are delivered to Client, Photographer will not permanently archive the images. It is Client's responsibility to back-up and protect the photographs.

CANCELLATION/RESCHEDULING

CANCELLATION: In the event the wedding is canceled, the retainer is NON-REFUNDABLE.

COVID: In the event that the wedding is rescheduled because of complications due to COVID-19, the retainer may be applied towards a rescheduled event on a date the photographer has available. If photographer is unavailable, the retainer is non-refundable.

NO SHOWS: Photographer is not responsible if Client and/or key individuals fail to appear during photographic session, or for missed images due to details not revealed to Photographer. If Client and/or key individuals fail to appear at a scheduled event, the retainer is non-refundable.

WEATHER: If it is not possible for an engagement, bridal or related sessions to take place on a scheduled day due to weather, Photographer and Client will reschedule on the earliest date possible, with no additional charge.

REFUNDS: In the event that Client is dissatisfied with the final results, Photographer will not offer refunds. For sessions prior to the event, retakes will be offered at an additional, discounted price; however, Client will receive images from the second session only.

USAGE

COPYRIGHT: It is understood that Photographer owns the copyright to all images. Client agrees not to edit, adjust, scan, copy or reproduce images in any manner. Client also agrees not to supply images to any businesses or publications of any kind, including vendors associated with the wedding, without Photographer's written permission.

LICENSING: Upon receipt of final payment, Client is granted a usage/print release to use digital images for non-commercial purposes, such as printing, exchange with family and friends, or display on the internet.

MODEL RELEASE: Client hereby grants to Photographer unrestricted rights to use and publish photographs. Photographer reserves the right to use images for display, trade, publication, advertising, photographic competitions, or other purposes. Client releases all claims to profits that may arise from use of images.
