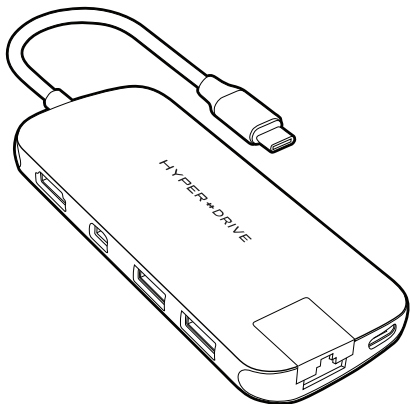

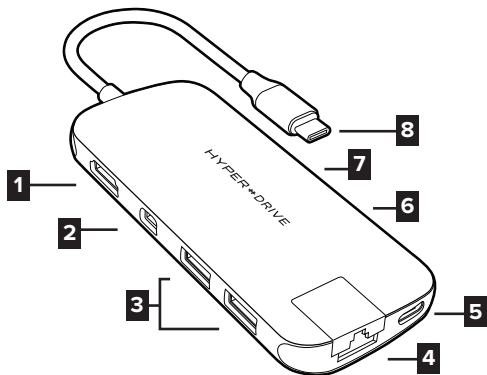
Introduction
