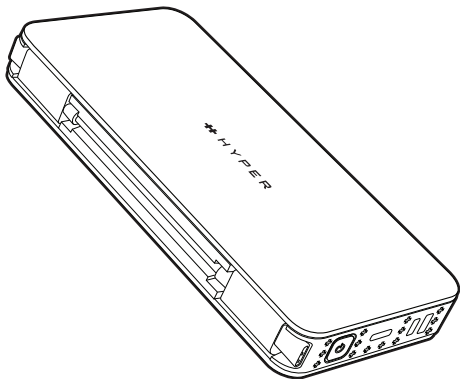

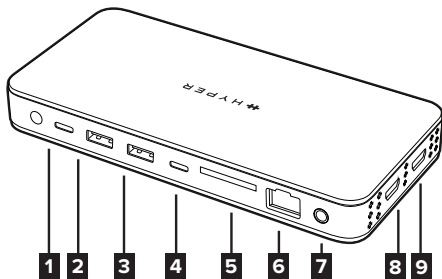

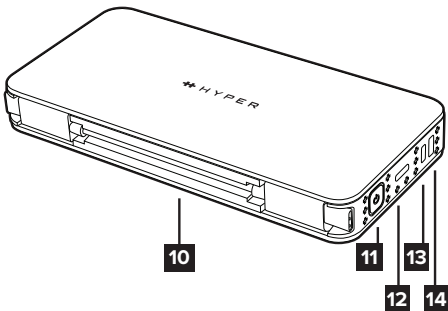

Powering the Dock and LED Indication

The HyperDrive Next 10 Port Business Class USB-C Dock can be powered by external USB-C PD charger or DC power adapter. The LED light lit up when the power source is plugged into it.

Multi-Display Support

Up to 2nd extended display output is supported if the host device supports DisplayPort Alt Mode.
