## TUSHY'S "SUPER BOWEL" CONTEST OFFICIAL RULES

- 2. **Eligibility.** The "Super Bowel" Contest (the "**Contest**") is open solely to legal residents of the fifty (50) United States and the District of Columbia who are 18 years of age or older at the time of entry. Employees, officers, directors, or agents of Tushy or any of Tushy's partners, related companies, agencies, or agents, as well as the immediate family (defined as spouse, parents, siblings, children, and grandparents) and same household members of any such employee, officer, director, or agent, are not eligible to participate. - 3. **How and When to Enter.** The entry period for the Contest begins at 3:30 p.m. Pacific Standard Time on February 13, 2022, and ends at 11:59 p.m. Pacific Standard Time on February 14, 2022 (the "**Entry Period**"). Tushy's computer is the official timekeeping device for this Contest.

You also must follow @hellotushy on Twitter or Instagram. If not DMing @hellotushy on Twitter or Instagram to enter the Contest, the profiles of eligible entrants must be public.

All entries must be received by 11:59 p.m. Pacific Standard Time on February 14, 2022. Limit (1) Entry per person during the Entry Period. Multiple Entries will not be accepted, including, for example only, and without limitation, the same or different submissions by the same person through various social media accounts.   - Color of Entry;
  - Mass of Entry; and
  - Extra Flair of Entry

In the event of a tie, tie breaker will be based upon the highest point score for Extra Flair of Entry, continuing thereafter to each judging criterion in the order listed above, as needed, to break the tie. If a tie still exists, a new set of Judges will rejudge the tied Entries to break the tie(s) in accordance with the foregoing criteria.

## 7. Selection of Winners; Notification.

a. **Grand Prize Winner Selection**. One (1) Grand Prize Winner will be selected by a panel of Tushy judges based on the judging criteria. The Grand Prize Winner will be announced not earlier than February 22, 2022.

Tushy is not responsible for digital communications that are undeliverable as a result of any filtering of any kind, insufficient space in an Entrant's account, or any other failure beyond its reasonable control. Each of the parties irrevocably waives, to the fullest extent permitted by law, any objection that they may now or hereafter have to the laying of venue of any such proceeding in such courts and any claim that any such proceeding brought in any such courts has been brought in any inconvenient forum.
