Authorized Dealer Terms and Conditions

- **Orders:** Dealer must place a minimum initial order of 4 guitars. This order can be split into 2 orders of 2 pieces. All orders require an accepted dealer application. All orders require pre-payment, credit card payment or certified COD. Our wiring instructions are as follows:

- **Display:** Dealers will use their best efforts to maintain at least 4 models on display.
- **Shipping:** St. Blues provides free shipping to domestic US Dealers in the continental United States. St. Blues uses FedEx Ground to ship within the continental US and FedEx International Economy for international orders. For international orders please be aware that you are responsible for all shipping, duties, and taxes.
- **Limited Warranty:** Dealer agrees to comply with its obligations under St. Blues' warranty as stated on the St. Blues website. If Dealer is presented with a warranty claim, the Dealer should contact St. Blues who will decide whether to have the defective product shipped to its offices for repair or to supply Dealer with replacement parts and to reimburse Dealer for repair costs.
- **Pricing:** Dealer agrees to not discount St. Blues guitars in advertising below 15% of Retail Price as shown on the Price List..
- **Auction sites:** Dealer may not sell guitars at online auction sites. eBay sales are allowed, only if dealer has a "store" by their name, and only with "buy now" option, adhering to retail pricing.
- **Territory:** St. Blues appoints Dealer as its authorized retail distributor for the territory within 70 miles of Dealer's store.
- **Term:** All Dealer appointments as Authorized Dealers are for a one-year period.
- **Rights Reserved to St. Blues:** St. Blues reserves to itself all of its right, title and interest not granted specifically to Dealer, including the right, to: (i) appoint other distributors in the Territory upon sixty (60) Days notice to Dealer; and (ii) provide direct service responsibility for certain Products and/or to assign warranty and other mechanical service responsibilities to any other servicing agency.
- **Intellectual Property Rights:** St. Blues reserves to itself all patent, copyright, trademark, trade secret and other intellectual property rights in its guitars and basses. No title to, ownership of, license or sublicense in any intellectual property rights related to any Product is transferred or assigned to Dealer. Dealer will not claim or attempt to misappropriate, circumvent or violate any of Manufacturer's intellectual property rights or other interests in the Products.
- **Confidential information:** Each Party hereto may disclose to the other Party certain trade secrets, proprietary or confidential information ("Confidential information"). A Party hereto will use such Confidential Information only for the purposes for which it is disclosed by the disclosing Party, will not disclose it to any third party and will take appropriate steps to protect it from any unauthorized use by or disclosure to any entity or person.
