

**TUNED IN TOKYO PROJECT BUILD GIVEAWAY 3  
OFFICIAL RULES**

**NO PURCHASE NECESSARY. PURCHASE OR ACCEPTANCE OF  
A PRODUCT OFFER WILL NOT IMPROVE YOUR CHANCES OF WINNING**

1. **PROMOTION PERIOD:** The Tuned in Tokyo Project Build Giveaway 3 (the "Sweepstakes") begins at 12:00:00 AM PT on October 19, 2018 and ends at 11:59:59 PM PT on February 4, 2019 (the "Promotion Period"). Sponsor's computer is the official time-keeping device for the Sweepstakes.
2. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of the 50 United States (excluding RI) and the District of Columbia and legal residents of Canada (excluding Quebec), who are licensed drivers, 18 years of age or older (or legal age of majority in their jurisdiction of residence). Void in RI, Quebec and where prohibited.
