

**TUNED IN TOKYO PROJECT BUILD GIVEAWAY 4
OFFICIAL RULES**

**NO PURCHASE NECESSARY. PURCHASE OR ACCEPTANCE OF
A PRODUCT OFFER WILL NOT IMPROVE YOUR CHANCES OF WINNING**

1. **PROMOTION PERIOD:** The Tuned in Tokyo Project Build Giveaway 4 (the "Sweepstakes") begins at 12:00:00 AM PT on February 5, 2019 and ends at 11:59:59 PM PT on May 26, 2019 (the "Promotion Period"). Sponsor's computer is the official time-keeping device for the Sweepstakes.
2. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of the 50 United States (excluding RI) and the District of Columbia, and residents of Canada (excluding Quebec) who are licensed drivers, 18 years of age or older (or legal age of majority in the jurisdiction in which they reside). Void in RI, Quebec and where prohibited. Employees of Tuned In Tokyo LLC, its affiliates, subsidiaries, advertising, promotion and internet agencies (collectively "Released Parties") and their immediate family members (spouse, parent, child, sibling, grandparent) and/or those living in the same household of each (whether related or not) are not eligible. 3. **HERE'S HOW IT WORKS:** During the Promotion Period you will automatically receive one (1) entry into the Sweepstakes for every \$1 spent on an eligible purchase at www.tunedintokyo.com (the "Website"). **The number of entries you receive will be based on the list price of your eligible purchase (excludes sales tax and shipping/handling charges), less any credits or discounts, and will NOT be rounded to the nearest dollar.** If a purchase is returned prior to the Sweepstakes drawing, entry will be voided. Your purchase transaction must be received by 11:59:59 PM PT on May 26, 2019 to be eligible to receive entries.

***DOUBLE ENTRIES:** You will earn double entries (two entries for every \$1 spent at www.tunedintokyo.com from February 5, 2019 through 11:59:59 PM PT on February 24, 2019 and again beginning May 12, 2019 through 11:59:59 PM PT on May 26, 2019 (each a "Double Entry Period").

To enter without making a purchase, on a plain piece of 3"x5" paper, hand print your first and last name, street address, city, state/province, zip/postal code, date of birth (mm/dd/yyyy), e-mail address plus daytime telephone number including area code. Then, on the opposite side of your entry, in 25 words or fewer, complete the following sentence: "I want to win the Tuned in Tokyo Project Build Giveaway because...." Mail your entry in a #10 business-size envelope with sufficient postage affixed, to: Tuned in Tokyo Project Build Giveaway 4, POB 398, Plainview, NY 11803-0398. Limit one entry per outer-mailing envelope. Bulk shipments (multiple entries in one shipping package) will not be accepted. Entries must be postmarked by May 28, 2019 and received by May 31, 2019. Mail-in entry, including outer-mailing envelope must be handwritten. No mechanically reproduced entries or metered mail permitted. Statements contained in mail-in entries will not be judged but must be unique; Statements must not in any way reflect negatively upon Sponsor, the promotion or any other person or entity. Each mail-in entry received will count as 5 entries into the Sweepstakes provided that the mail-in entry complies with the above requirements. Mail-in entries that are not in the format specified above, that are illegible, inaccurate, incomplete, or reproduced via photocopier or otherwise will be considered null and void. Proof of submission does not constitute proof of receipt. In the event the postmark date falls on a Sunday or federal holiday, the mail-in entry must be postmarked by the following business day.

4. **RANDOM DRAWING:** A random drawing will be conducted on or about June 3, 2019 from among all eligible entries received. The random drawing will be conducted by an independent judging organization whose decisions are final. Odds of winning will depend upon the number of eligible entries received.
5. **WINNER NOTIFICATION:** Potential winner will be notified by email, mail, and/or phone. Potential winner will be required to complete and return an Affidavit of Eligibility, Release of Liability, Prize Acceptance Form, (a W-9 Tax form for U.S. residents)

and, if legally permissible, a Publicity Release within 3 days (including Saturdays, Sundays and Holidays) of attempted delivery of same. If potential winner is a resident of Canada, he/she will also be required to correctly answer a mathematical skill question administered online/by mail/via telephone, at the Sponsors sole discretion, prior to the awarding of the prize.
