I understand the Deirdre Handcrafted Jewelry will retain the prototype and one sample from a production run.

I agree to have Deirdre Handcrafted Jewelry be the sole production company for this project for a minimum of 7 years.

I allow Deirdre Handcrafted Jewelry to use photos of my pieces and samples in promotional materials.  Check here if you do not want photos and samples used.

I understand when my order is placed that there may be a 5% underage in quantities and understand that those items are not on back order unless clearly stated on the invoice.

Check here if you would like to purchase any overage pieces (up to 5%) Deirdre Handcrafted Jewelry will call to confirm before charging.

I understand that metals are a commodity and prices are subject to change. I accept that if there is a significant change in price from the day I place my order to the day that the metal is priced, I will pay the increased cost of purchase.
