**Inhalation:** First aid is not normally required. If breathing difficulties develop, move victim away from source of exposure and into fresh air in a position comfortable for breathing. Seek immediate medical attention.

Ingestion: First aid is not normally required; however, if swallowed and symptoms develop, seek medical attention.

**Most important symptoms and effects, both acute and delayed:** Inhalation of oil mists or vapors generated at elevated temperatures may cause respiratory irritation. #### Specific hazards arising from the chemical

**Unusual Fire & Explosion Hazards:** This material may burn, but will not ignite readily. If container is not properly cooled, it can rupture in the heat of a fire.

# **SECTION 6: Accidental release measures**

**Personal precautions, protective equipment and emergency procedures:** This material may burn, but will not ignite readily. Keep all sources of ignition away from spill/release. Stay upwind and away from spill/release. Avoid direct contact with material. For large spillages, notify persons down wind of the spill/release, isolate immediate hazard area and keep unauthorized personnel out. # SECTION 7: Handling and storage

**Precautions for safe handling:** Keep away from flames and hot surfaces. Wash thoroughly after handling. Use good personal hygiene practices and wear appropriate personal protective equipment (see section 8). Do not enter confined spaces such as tanks or pits without following proper entry procedures such as ASTM D-4276 and 29CFR 1910.146. Spills will produce very slippery surfaces. Do not wear contaminated clothing or shoes.

**Conditions for safe storage:** Keep container(s) tightly closed and properly labeled. Use and store this material in cool, dry, well-ventilated area away from heat and all sources of ignition. Store only in approved containers. Keep away from any incompatible material (see Section 10). Protect container(s) against physical damage.

Toxicity: Harmful to aquatic organisms, may cause long-term adverse effects in the aquatic environment Experimental studies with rainbow trout, daphnia, and fresh water algae indicate that synthetic base oils are not expected to be harmful to aquatic organisms.

Persistence and Degradability: Polyalphaolefins (synthesized hydrocarbons) & polyalkylene glycol synthetic base oils are not considered to be readily biodegradable but may be inherently biodegradable. They are expected to completely biodegrade over extended periods of time. Most synthetic polyol esters are considered readily biodegradable and are expected to completely biodegrade over extended periods of time.

Bioaccumulative Potential: PAO synthetic base oils are not expected to bioaccumulate.
