

OFF LICENCE

Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **Malts of Distinction Limited** is authorised to sell or deliver alcohol from the premises situated at 29 Manuka Street, Taupo, and known as The Whisky Shop NZ, to any person for consumption off the premises.

ENDORSEMENT

Section 40 of the Act applies to this licence and the licensee is authorised to sell alcohol from (but not on) the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager, or managers, appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold from the premises at any time on any day, and delivered somewhere else for consumption off the premises only on the following days and hours as set out in condition (3) of this licence.
2. **No alcohol is to be delivered from the premises on Good Friday, Easter Sunday or Christmas Day or before 1.00pm on Anzac Day.**
3. **No alcohol is to be delivered to the buyer (or to any other person on the buyer's behalf) at any time after 11.00pm on any day and before 6.00am on the next day.**
4. The licensee must follow the procedures set out in Regulation 14 & 15 of the Sale and Supply of Alcohol Regulations 2013 to ensure that neither the purchaser nor the person to whom alcohol is delivered is a minor.
5. The licensee must display on its website and/or in its catalogue and on every receipt issued for alcohol sold remotely:
 - the licence holder's name and licence number;
 - the date on which the licence expires;
 - a legible image of the licence or a clearly identified link to such an image.

THE LICENSED PREMISES

The sale or delivery of alcohol is authorised from the premises generally. The premises situated at 29 Manuka Street, Taupo are more precisely identified as outlined in a plan date stamped as received by the Taupo District Licensing Committee on 2 March 2015. A copy of this licence must be displayed as prescribed in condition (4) of this licence.

DURATION


Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -

- (a) Until the close of the period of 1 year commencing with the date of its issue; or
- (b) If an application for the renewal of the licence is duly made, until the application is determined; or
- (c) If the licence is renewed, until the close of the period of 3 years after the period for which it was renewed.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, the licence expires on: **1 May 2019**
