## 4. First-aid measures

# 5. Fire-fighting measures

Suitable extinguishing media

# 6. Accidental release measures

Methods and materials for containment and cleaning up

Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Keep combustibles (wood, paper, oil, etc.) away from spilled material. Ventilate the contaminated area. Stop the flow of material, if this is without risk. Absorb in vermiculite, dry sand or earth and place into containers.

Large Spills: Wet down with water and dike for later disposal. Shovel the material into waste container. Minimize dust generation and accumulation. Following product recovery, flush area with water

Small Spills: Sweep up or vacuum up spillage and collect in suitable container for disposal. Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.
