



INSTALLATION INSTRUCTIONS

Legato Performance Exhaust Kit #LEX4104

For 2015-'17 Ford Mustang GT 5.0L V8

409 Stainless Steel w/304 Stainless Steel Tips

Fits Coupe and Convertible

Removal of Stock System:

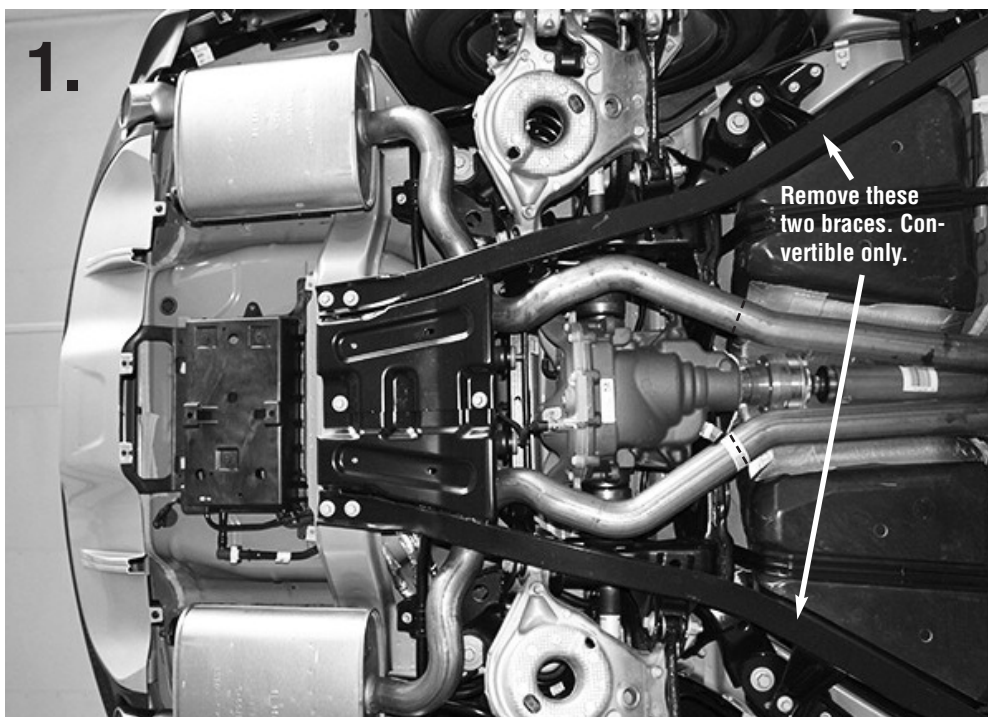
1. If a hoist or rack is available, raise the vehicle to a comfortable working height. If no lift is available you can jack up the vehicle and support it with jackstands. Make sure that the vehicle is safely positioned on the jackstands before getting under it.
2. Spray a penetrating lubricant onto the rubber hangers just behind the rear end housing and also at the rear of the vehicle.
3. On Convertibles the body braces shown in Photo #1 below have to be removed in order to remove the stock exhaust system and to install the new Legato parts. Start with the brace on the passenger side of the vehicle. Loosen the front bolt and then remove the next eight bolts. Remove the brace from the car. Repeat on driver's side with the six bolts on that side.
4. To start, measure back 2-1/2" from the beginning of the straight area (see Figure 2 on next page) and mark as shown on both pipes. Support the exhaust system both in front and behind the area to be cut. Once you are confident of your measurements, cut both pipes at the marks. **Note: Use extreme caution in cutting due to the close proximity of the gas tank.**
5. Using a 13mm wrench, unbolt the two hangers from the crossmember that is located just behind the

rear differential. Carefully lower the stand supporting the muffler and slide the muffler assembly forward to and out of the rear hanger mount. Repeat for the other side. Lower the assemblies to the floor leaving the front hangers attached.

6. Using a file or a die grinder, carefully deburr the end of the pipes where you made your cut.
7. Using a 13mm wrench, remove the two hanger mounts at the rear of the vehicle from the frame. As they are removed, place them next to the factory muffler of the corresponding side.

Installation of the Legato Exhaust System:

1. Place the Legato muffler units adjacent to the factory units and swap the front and rear hanger mounts from the stock mufflers to the Legato assemblies. Also place one of the supplied 2-1/2" clamp onto the inlet pipe of each assembly. Tighten the clamp just enough to hold in place.
2. Place the right muffler assembly (#4104-2) up in position and slide the inlet completely onto the factory pipe. Support the assembly with a stand and remount the rear hanger mount to the frame and tighten securely. Remount the front hanger to the cross member and tighten securely. Leave the inlet clamp loose for now. Repeat this step with the left muffler assembly (#4104-1) on the left side of the vehicle.



3. Adjust and level the two mufflers to provide a satisfactory fit. Check that the tips are positioned correctly. Once everything is positioned correctly you can tighten down the two clamps. Make sure that a minimum of 1/2" clearance is maintained around all parts of the system taking into consideration suspension travel and vibration.
4. For a totally secure installation we recommend a 1" weld on either side of the slip fit connections.
5. Replace the two frame braces you removed on convertible installations. Tighten bolts securely.

Before cutting any pipes, try to make your own best estimate of where to cut to avoid any mistakes. Due to vehicle manufacturer variances, the indicated cut area in this illustration could be slightly different on your car. Please check carefully before cutting.

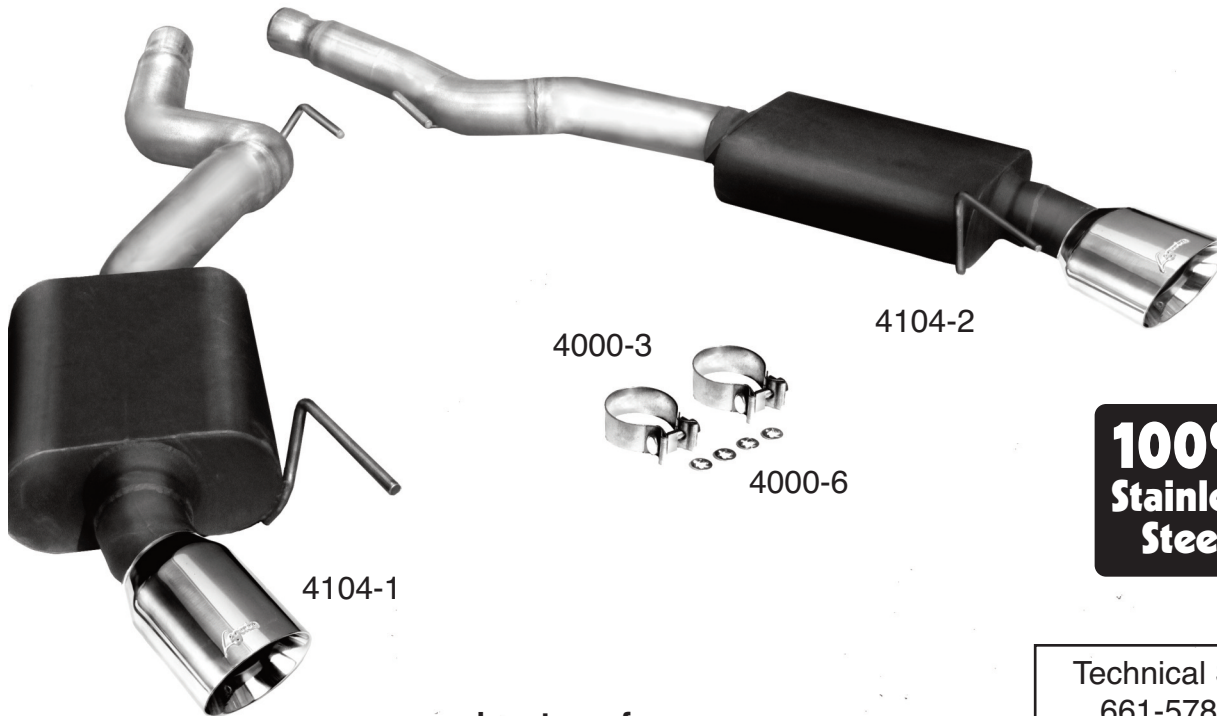

Lifetime Limited Warranty on Legato Exhaust Systems

Legato extends the following limited warranty to the original purchaser of a Legato exhaust system. Legato warrants its exhaust products against defects in materials and workmanship for the buyer's lifetime from the date of original purchase. This applies only to the original purchaser and the parts must remain installed on the original vehicle for which they were purchased. This warranty is void if the product was improperly installed, was installed on a vehicle for which it was not designed, if it was modified in any manner, or was removed from the original vehicle and reinstalled on another vehicle.

This warranty shall not apply to any product installed on a racing vehicle, installed improperly, or contrary to Legato's instructions, altered, misused, or repaired or damaged from an accident, collision, or willful or negligent act. To make a claim under the terms of this Warranty, the original purchaser must return the product to Legato along with proof of original purchase. Purchaser must call Legato (661-578-5448) to obtain a Returned Material Authorization (RMA). Proof of purchase must clearly show the place of purchase, purchase price, product purchased and date of purchase.

If, upon inspection, Legato determines a defect in materials or workmanship, Legato will refund the returned goods shipping expense, and replace the defective part or parts with a new part or parts.
