AN INSPECTOR CALLS

A practical course for managers, supervisors and staff who may meet with Inspectors from the HSE or Local Authority following an incident or complaint being made.

This course will effectively prepare candidates for being interviewed by an Inspector.

It is important to ensure that relevant personnel are aware of the correct procedures, documentation and verbal responses to follow when 'An Inspector Calls' in response to a reportable accident or incident. This can save you from prosecution and unnecessary 'Fees for Intervention' costs.

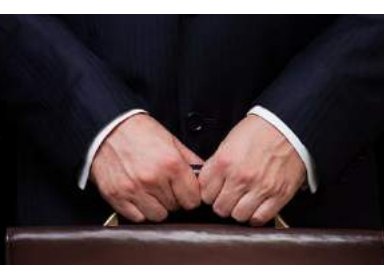
The effect of an accident can be far-reaching with a variety of legal, moral and economic costs involved.

An enforcement visit often occur when effective senior management support may be unavailable, placing other personnel in the spotlight.

This simulation, based on your organisation's own chosen scenario, helps mitigate the risk of legal action being initiated. Active staff participation will also ensure enhanced awareness of potential hazardous situations.

Verbal feedback is given on the day and a subsequent written report is produced which can be used to prioritise remedial actions.

A return visit to the site is scheduled after three months to review ongoing corrective actions and give further advice if necessary.



AN INSPECTOR CALLS - SUGGESTED SCENARIOS

It can be advantageous to analyse accident or incident statistics and use the scenario exercise to reflect trends. The scenario can then demonstrate the effect of corrective actions not being taken.



Suitable example scenarios are given below:

TRAINING DAY

- Initial accident/incident scenario
- Enforcement officer arrives
- Inspection of scenario and surrounding workplace
- Initial explanation of powers of inspectors, including the Fees for Intervention scheme
- Interview of staff
- Feedback and conclusion
- Follow-up action plan
- Three month return visit

TASK	ACCIDENT
Change filters	Entanglement with belt drives/rotating shaft Falls from height
Work on fans	Entanglement with moving parts Severe lacerations/amputations
Accessing valves	Falls from height
Work by an unprotected edge such as a working platform or opening in the floor	Falls from the working platform or into the opening
Work on electrical circuits, switching or cabling at voltages of 230V or higher	Electrocution or burns Fall from height if work being undertaken from a ladder or platform
Work on cooling towers	Falls from height
Work in vehicle-movement area	Crushed between moving vehicle and fixed surface
