


INSTALLATION INSTRUCTIONS

Wiring our RetroSound® dash speakers for two channel operation:




Wiring our RetroSound® dash speakers in series so the amplifier sees an 8 ohm load:



INSTALLATION RECOMENDATIONS


Universal Speaker Bracket RS-UB1KT (sold separately)

This 14-inch bracket, when installed in the threaded mounting point at the rear of our dash speakers, allows you to make your own custom speaker bracket. You can modify the bracket to solve challenging installations where no other options are available.



INSTALLATION RECOMENDATIONS

The bracket can be bent or trimmed to virtually any shape to accomplish your installation goals. Below are some examples of a few of the shapes to which you can bend the bracket, helping you to mount the speaker into the dash, rear seat or rear package tray.
