At Kairos Vision Care ("Kairos", "Company," "us," "we," or "our") we value and prioritize the privacy of individuals who engage with our website, services, or products (hereinafter referred to as "Services"). This Privacy Policy outlines how we collect, use, protect, and disclose your personal information that arises from your utilization of our Services. Please read it carefully.

This Privacy Policy applies to all personal data collected through written, electronic, or oral communications when you visit and interact with our website at <u>www.kairosvisionpr.com</u>, along with any services, websites, pages, features, or content that we own or operate.

By using our Services, you acknowledge and consent to abide by this Privacy Policy and agree to our Terms and Conditions of Use. If you do not agree with any aspect of this Privacy Policy or our Terms and Conditions of Use, we kindly ask that you immediately refrain from accessing or using our Services.

CHANGES TO OUR PRIVACY POLICY

We reserve the right to update our Privacy Policy from time to time. Any modifications will be communicated by posting the revised Privacy Policy on this page. Additionally, we will notify you through email or with a noticeable announcement on our website before the changes come into effect. The "effective date" at the top of this Privacy Policy will also be updated accordingly.

INFORMATION COLLECTED

<u>Personal Data</u>: When you use our Services, we gather certain personal data. Personal information generally includes data that can identify an individual or is linked to an identifiable individual. This may include, but is not limited to, first and last name, email address, date of birth, phone number, physical address, payment account or card details, shopping or payment preferences, browsing history, and eye prescription information. We or third-party service providers assisting us may collect various types of personal information from you, including but not limited to:

<u>Create an account</u>: When creating an account with us, you will be required to provide your first and last names, birth date, email address, and choose a password for your future logins.

<u>Order placement</u>: When placing an order with us, you must provide information such as your first and last name, delivery address, email address, phone number, payment account or credit card details. Moreover, we may gather data concerning your eyeglass prescription and specific measurements related to your eyes, vision, vision health, and eyeglass needs. If you furnish any sensitive information, like details about your medical or health conditions, we will manage, process, and disclose this information in accordance with relevant legal and regulatory requirements.

<u>Payment information</u>: When you make purchases, we may collect payment card information, shipping and billing addresses, and phone numbers.

<u>Prescriptions</u>: When purchasing prescription products, you will be required to provide us with your eye prescription details.

<u>Customer Service</u>: When reaching out to our customer service department, you may be required to furnish us with further information to help us address your inquiries or issues thoroughly and completely.

<u>Promotional Emails</u>: If you wish to receive promotional emails from us with news and exclusive offers, you may provide us with your email address.

<u>Promotional Messaging</u>: If you wish to receive promotional text messages from us with news and exclusive offers, you may provide us with your phone number.

INFORMATION WE COLLECT AUTOMATICALLY

<u>Usage Data</u>: We collect information that your browser sends whenever you use our Services or access them from any device. This Usage Data could encompass details like your computer's IP address, browser type, version, the specific pages of our Services you visit, the date and time of your visits, the duration spent on those pages, unique device identifiers, and other diagnostic information. COOKIES

We may automatically collect information when you use our Services through "cookies" and similar technologies ("Tracking Technologies"). These technologies help us gather data about your usage of the Site and enhance your experience with our Services. We can store cookies on your device if they are essential for the website's functionality. For all other types of cookies, your consent is required.

Cookies are small pieces of data stored within your Internet browser by websites you visit, allowing those sites to recognize the same browser when you return online later. We may employ cookies provided by third-party service providers that use data from your visits to other websites to target advertisements for products and services. Cookies can also enable us to track and target the interests of our users to enhance the experience on our website. We do not monitor the specific information gathered and stored by these third-party cookies. For information on their use of cookies, please refer to the third-party's website.

We use cookies to personalize content and ads, to provide social media features and to analyze our traffic. We also use cookies to understand how you use functionality available on this website like search or favorites. You can request that we limit our processing of your personal information under certain circumstances, such as disputing its accuracy or objecting to our processing activities. You may object to our processing of your personal

information at any time if it is based on consent or legitimate interests. However, we may continue processing if necessary for legal defenses or other permissible reasons.

To protect your privacy, we need to verify your identity before processing your request. This verification may involve contacting you by phone or email. <u>Retention of Data</u>: We will keep your personal data for as long as necessary to fulfill the purposes stated in this Privacy Policy. We will continue to use and store your personal data as necessary to comply with legal obligations, resolve disputes, and enforce our agreements and policies.

<u>Usage of Data</u>: Usage data will also be retained for internal analysis purposes. Typically, usage data is kept for a shorter period, unless it is necessary for enhancing security, improving Services functionality, or required by law to retain such data for longer periods.

<u>Security of Data</u>: We implement security measures to protect your personal information from loss, misuse, and unauthorized changes. However, please note that no data transmission over the internet can be entirely secure. While we strive to protect your data, we cannot guarantee the security of our databases or third-party databases. If you suspect any compromise to your account security, please contact us immediately. Every 24 months we purge information that does not serve the purposes specified in this Privacy Policy.

<u>International Transfers</u>: As an online retailer based in Puerto Rico, your personal information may be transferred to, processed, and stored in locations where data protection laws may differ from those in your jurisdiction. We take appropriate measures to protect your personal data in accordance with applicable laws.

CHILDREN'S PRIVACY

Our website is not intended to be used by individuals under the age of 21. We do not knowingly collect or distribute personal information directly from children under 21 years old. However, if parents or legal guardians order children's glasses through our Services, we may collect prescription information for children under 21, and other necessary details to deliver our products. This information is solely used for fulfilling the order and is subject to applicable laws.

If a parent or guardian becomes aware that his or her child has provided us with information without his or her consent, he or she should contact Kairos. We will erase that information from our files within a reasonable time.

SALE OR SHARING OF PERSONAL INFORMATION

We do not knowingly sell or share the personal information for cross-context behavioral advertising purposes.

DO NOT TRACK

We respect Do Not Track signals and do not track, plant cookies, or use advertising when a user's web browser sends a Do Not Track signal. Do Not Track is a preference that can be set in your web browser to notify websites that you prefer not to be tracked.

YOUR CONSENT

CALIFORNIA CONSUMER PRIVACY ACT

If you reside in California, you have the right to ask us one time each year if we have shared personal information with third parties for their direct marketing purposes. If you reside in California, you can make the following more specific requests:

You have the right to request disclosure of the following information from us: the categories of personal information we collected about you, the sources from which we collected the personal information, the categories of personal information we sold or disclosed, our business or commercial purpose for collecting and selling the personal information, the categories of third parties with whom we shared the personal information, and the specific pieces of personal information we collected about you over the past 12 months.

You can request that we delete your personal information that we maintain about you, subject to certain exceptions. We do not sell your personal information. In the context of this Privacy Policy "sell" refers to the act of selling your personal information to an external party in exchange for monetary or other valuable considerations, with exceptions as outlined in relevant California law.

You must provide us your mobile number voluntarily on our website or email marketing communications.

TELEPHONE CONSUMER PROTECTION ACT

The Telephone Consumer Protection Act regulates telemarketing calls, auto-dialed calls, prerecorded calls, text messages, and unsolicited faxes. It prohibits using automated prerecorded message to contact cell phones, and prerecorded telemarketing messages to contact residential phones, unless the recipient has provided and not
