BY SIGNING YOU ARE AGREEING THAT YOU ARE LEGAL TO OWN AND PURCHASE BODY ARMOR

We only sell to law-abiding adults. Body armor is a purely defensive item but, regardless, we are very sensitive to the possibility of our products being misused by criminals. By buying a product from us, you certify that you are a law-abiding adult **with no felony convictions**. We reserve the right to refuse to sell to anyone, in our sole discretion. By buying An OUTERARMOR TACTICAL product you guarantee that you are not legally prohibited from owning firearms or Body Armor and also that you are not associated with any criminal group, in any way, and have only a lawful self-defense purpose for owning Body Armor.

AS PER THE NIJ, NO armor is 100% bulletproof. A 'bulletproof' vest or other armor will protect you from the vast majority of ballistic threats you are ever likely to encounter, however no armor can claim the ability to keep you 100% safe under all possible conditions. OuterArmor Tactical will protect you from the listed ballistic threats described by NIJ standards for each specific armor product sold. Please know that: Sharp-edged or pointed instruments (e.g., certain knives, ice picks, etc.), and/or other unusual ammunition or situations can defeat Body Armor.

It is also important to understand that at some angles projectiles can slide, or deflect off the edges of armor, or ricochet. Furthermore, projectiles that are successfully stopped by armor will always produce some level of injury, resulting in severe bruising, broken bones, and possibly serious internal injury or even death due to the projectiles kinetic energy which continues on after the projectile itself is stopped. Soft Body Armor defeats most pistol and shotgun projectiles, but no body armor on earth makes you invulnerable to all threats. To state the obvious, getting shot always carries some risk.

Be aware that your head is much more susceptible to blunt trauma than your body. ANY impact of a bullet on a helmet will cause injury and can cause death. You put the odds more in your favor with head protection, but, just as with any armor, no guarantee of invulnerability can be made. By buying Body Armor you assume all risks of use or misuse, and agree not to hold us liable in any way. In addition, you are responsible to ensure that your ballistic panels are positioned properly to provide you the maximum protection from the threat.

We assume no liability. We neither assume, nor authorize any person to assume for us any liability in connection with the sale or use of the goods sold, and there are no oral agreements or warranties collateral to or affecting this agreement. We hereby give notice that any statement made by us in the sale of the goods, shall not create any warranty that the goods shall be fit for any particular purpose outside of or in addition to the standard minimum U.S Government NIJ requirements or other NIJ certified Laboratory or organization. Statements, images or descriptions are informational only, and not made or given as a warranty of the goods in any way. We specifically disavow any other representation, warranty, or liability related to the condition or use of the goods. As per industry standard, all OuterArmor plates and soft armor is warranted for a period of no more than (5) Five years; at which time and depending on how the armor was used and cared for, even the minimum standard NIJ levels of protection may not be valid. This is an industry wide standard and includes even law enforcement purchases.

We do not cover any consequential damages, and our liability is limited to repairing or replacing defective goods. The entire risk as to the quality and performance of the product is with the buyer. We are not an insurer, and bear no liability for any use, misuse, or failure to perform. Also be advised, all hard plate outer covering materials and informational decals, while being used inside a plate carrier vest will tend to show wear of various kinds. This is normal and should not be considered as a product defect or warranty issue.

Purchaser covenants and agrees that the purchaser or his heirs, agents, assigns shall never bring any action in any court of law. Any dispute arising from the purchase and sale of product(s) sold by OUTERARMOR TACTICAL shall be resolved by arbitration in accordance with the then-current American Arbitration Association (AAA) rules for arbitration of business disputes. Any court having jurisdiction thereof may enter judgment upon the award rendered by the arbitrator. The place of arbitration must be NEVADA, USA. The laws of the State of NEVADA, USA shall apply to all transactions.
