

Official Rules: Blitz Assembly 2018

Please read these Official Rules before entering this promotion (the "Promotion"). By participating in the Promotion, you agree to be bound by these Official Rules and represent that you satisfy all of the eligibility requirements below.

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR TO WIN THIS PROMOTION.

1. **Eligibility.** The Promotion is open only to legal residents of Washington, age 18 or older and who are in one of the following professions: teacher, educator, school nurse, school nutrition director or manager employed by a Washington school district or school. The individual must be signed up as a Program Advisor on FuelUptoPlay60.com, and have completed in their school and "marked as complete" Step 1, Step 2, Step 4 and Step 5 on their dashboard on FuelUptoPlay60.com from August 17, 2017-February 28, 2018. Upon entering the Promotion, at the time of the drawing, following the drawing, and if asked must provide an affidavit of eligibility. If you do not meet these requirements or any other eligibility requirements in these Official Rules, you are not eligible to win a prize, and the Washington State Dairy Products Commission ("Sponsor") reserves the right not to award prizes to you. Employees, directors, officers and contractors of Sponsor and Sponsor's advertising and promotion agencies, and their respective immediate family members and/or those living in the same household of each, are not eligible to win. The Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited. Odds are dependent on number of entries.
2. **Promotion Period.** The promotion will take place August 17, 2017-February 28, 2018. All entries must be received during the Promotion Period to be eligible to win a prize.
3. **How to Enter.**
 - a. Create and use a Program Advisor account on www.FuelUptoPlay60.com. Complete a Kickoff Activity (Step 1), Draft Players (Step 2), an Eat Healthy Washington Local Play (Step 4), and a Game Time Play (Step 5) with your school. After completing the steps at your school, the Program Advisor must update their Fuel Up to Play 60 Dashboard: by selecting "mark as complete" for Step 1 and Step 2, and selecting the Healthy Eating Play and a Game Time Play, then "Add Play" button then "Submit" on the "Six Steps Progress page" for the Plays. The Date of completion must be between August 17, 2017 and February 28, 2018 to be entered to win.
 - b. Only one (1) entry per person during the Promotion Period above. Use of any automated system to participate is prohibited and will result in disqualification.

In the event of a dispute as to any registration, the authorized account holder of the email address that is used to enter will be deemed to be the registrant or Program Advisor. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address.

4. Prizes: Up to 12 winners will receive: One (1) Blitz Assembly at their school to be scheduled in April 2018. Blitz Assembly includes: 1 hour with Blitz the mascot of the Seattle Seahawks, 1 Seagal, Fuel Up to Play 60 movie showing, Fuel up to Play banners and flags for the event (provided by the Washington State Dairy Council). Quantity will depend on drawing winner locations.
5. Random Drawing: The winners will be selected in a random drawing from all eligible entries to be held on March 2, 2018. The winners will be notified by email (at the address provided in the Fuel Up to Play 60 website). Information regarding the Prize will be communicated by March 5, 2018. If a prize notification is returned as undeliverable or if the winner does not respond to the notification within seven (7) calendar days, it will result in disqualification, and the prize will be awarded to an alternate winner in a separate random drawing. The prize winners may be required to execute an affidavit of eligibility and liability/publicity release within seven (7) days following the date of attempted notification. Prizes are not assignable or transferable.
