### Quick Reference Setup Guide

Thank you for purchasing Unique Lighting Systems' SMRT Logic (LPLUS) Internet Gateway. The SMRT Logic® system allows users to intuitively set up and control their lighting systems from anywhere they have internet access via the web or the Unique Lighting SMRT Logic Lighting app.

## Setup in 3 Easy Steps!


### 1 Connect Hardware

### 2 Register

### 3 Configure

#### 1 Connect Hardware

1. Connect Ethernet cable from your internet router or switch to the port on the back of the LPLUS.



2. Plug in the AC adapter.



3. LPLUS lights flash. Left LED should eventually settle on solid green.



#### 2 Register

1. Next, register your LPLUS. Point browser to [www.smrtscape.com](http://www.smrtscape.com).
2. Click the **Register** link.
3. Fill out all fields and press **Register**.
4. A verification email will be sent to the specified e-mail address. Click the verification link in the e-mail. You will be taken to the SMRTscape website. Click the **Complete Registration** link.
5. You will be taken to the sign in page. Enter e-mail address and password then click **Sign In**.




## Add Location

After signing in, you need to add the location of the LPLUS.

1. Click **+ Add a Location**.



2. Fill out the Name and Description fields.
3. On the Google Maps map (**Figure 1**), enter desired


4. Click **Submit**.

## Add Scene

A default scene is added to the LPLUS setup screen. The default scene ("Scene 1") turns on every day of the week from Dusk to 10pm. There are two ways to edit scene elements:

### Scene name, description and image:


1. Click the "+" icon.
2. Enter scene name and description. You can also upload an image to replace the "default" image.

### Scene days of the week and run times:

1. Click the grey cog wheel by scene name (**Figure 2**).
2. Select which days of the week the scene will run and the times of operation for the specified days (**Figure 3**).

It is possible to have an A Schedule and a B Schedule for each scene. For example, one might want security lights to stay on longer on Friday and Saturday nights.

3. Click **Submit**.

## To Add a Scene

To add additional scenes to the LPLUS (see system diagram).


1. Click the **+ Add a Scene** button.
2. Follow same steps as above. Click **Create Scene**.

## To Delete a Scene

1. Press the trash can icon next to the Scene name.
2. Click the "Yes" button to confirm.

## Manual Scene Operation



To manually turn a scene on or off click green "Play" button on the scene and set the desired time (in minutes) then press "Turn On" button.



## Adding the LPLUS

Now add the LPLUS to your SMART Logic account.


1. At the computer, click the yellow "Devices" light bulb, and then click the "Add Gateway" button. Follow the prompts to add your gateway.
2. Type in the LPLUS ID. This is the "SUID" number on the sticker on the bottom of the unit.
3. Enter the Security Key which is also found on bottom. Click **Submit**.
4. The LPLUS should now be added to the system.



## Add LPCU-As to the LPLUS

At this time you can add LPCU-As.

1. Press the **Activate Discovery Mode** button.



2. Press the button on the front of the LPCU-A when prompted.
3. After a few seconds, the LPLUS should detect the LPCU-A. Give the detected LPCU-A a description and assign it to the desired scene.
4. Press the **Submit** button when done.
5. Repeat steps 1-4 for each LPCU-A to add.

 To add an LPRO, click **Activate Discovery Mode** then power cycle the LPRO. The LPRO may require a firmware update after adding. A notification will be shown under Hardware on the Location page.

## FCC and IC Statements

### FCC Statement - FCC ID: OF7SCG

This device complies with Part 15 of the FCC Rules. Operation is subject to the following two conditions: (1) This device may not cause harmful interference, and (2) this device must accept any interference received, including interference that may cause undesired operation.

### IC Statement - IC: 3575A-SCG

To reduce potential radio interference to other users, the antenna type and its gain should be so chosen that the equivalent isotropically radiated power (e.i.r.p.) is not more than that necessary for successful communication.

## Edit LPCU-A Equipment

Click the blue pencil icon to edit LPCU-A description or change scene assignment.

## Delete LPCU-A Equipment

Click the blue trashcan icon to delete a LPCU-A.

## Update the Firmware

If a firmware update is available for either the LPLUS or a LPCU-A, a **Manage Firmware** command will be displayed under 'Hardware' on the Location screen. Click the link to update hardware. Select the Device(s) and click **Update Firmware** to start.

## Troubleshooting

| Problem            | Cause   | Solution   |
|--------------------|---|--|
| LED remains orange | LPLUS unable to get an IP address from the network's DHCP server. | Confirm the network is configured to assign IP addresses. If needed, an LPLUS can be manually configured to use a static IP address. Refer to Advanced LPLUS network setup on the website. |
| LED blinks green   | LPLUS unable to reach the internet.                               | Confirm there is a valid internet connection using the same Ethernet wire if possible.   |
