## DESCRIPTION

This multipurpose towel was developed to safely remove mineral based stains from a variety of surfaces. Dual sided towel featuring a non-scratching textured side for those tough stains and a smooth side for those requiring less scrubbing. The formula has a pH of 1 so it has the power of an acid but is safer and mild to the skin like dish soap. Eliminate overspray of powerful acids into unwanted areas with the ease and convenience of the Enviro-Terra Towel.

## DIRECTIONS

Scrub surface with textured side of towel until stains and deposits disappear. Use smooth side to wipe the surface clean. Discard used towel. Water rinse recommended.

Avoid contamination of food in the use and storage of this product. Surfaces subject to direct food contact must be rinsed with potable water.

**Note:** This product should not be used on marble. Test on an inconspicuous area before using.

## DIRECTIONS FOR DISPENSING

1. Remove lid by lifting upward. Remove foil seal.
2. Pull towel from center of the roll and thread through "X" on the underside of the lid.
3. Close lid. Pull towel at 90° angle.
4. Snap hinged cap back into place to ensure towels stay moist.



## DISPOSAL

Offer empty container for recycling. If recycling is not available, discard container in trash. Do not flush wipes.
