DIRECTIONS

For washing with manual (non-motorized) brushes, use 3/8 ounce of Double Duty to 3 gallons of warm water in the first tank. (One stroke of a gallon pump dispenser gives 1 ounce.)

Rinse glasses with clear water in the second tank.

In the third tank, sanitize glasses in accordance with governing sanitary code. For perfectly clean and sanitized glasses, use SC Sanitizing Rinse or Bock Sanitizing Rinse.

Allow the sanitized glasses and utensils to air dry on a rack or drainboard. Do not towel dry.

DISPOSAL

Offer empty container for recycling. If recycling is not available, discard container in trash.
