## DESCRIPTION

Clean dispensing system lines are essential to serve the best tasting beer and wine. Use this product to make these dispensing systems absolutely clean, so beverages keep their natural aroma and true flavor. Regular cleaning of dispensing lines, taps and faucets will assure that your beer and wine taste and smell fresh and appetizing every time!

## DIRECTIONS

The amount of cleaning solution needed is determined by the length of the beer/wine lines. For short lines, 1 quart is sufficient. Longer lines will require 2 or 3 quarts.

Use 1 to 2 ounces of per quart of warm or cold water. Pump the cleaning system through the lines and then rinse with cold water or beer. To clean faucets, disassemble and soak in cleaning solution, then rinse faucet parts with clean water.

## DISPOSAL

Dispose of contents/container to comply with local/regional/national/international regulations.



## DANGER

Causes severe skin burns and eye damage. May cause respiratory irritation.

Do not breathe dust. Wash thoroughly after handling. Use only outdoors or in a well-ventilated area. Wear eye protection, protective clothing, protective gloves. Wash contaminated clothing before reuse.
